X _____ REFUND POLICY: Should the enrollee be terminated or cancel for any reason, all refunds will be made according to the following
Initial schedule:
1. Cancellation must be by certified mail to the above address.
2. All monies will be refunded if the applicant is not accepted by The Center or if the applicant cancels within three (3) business days after signing the Enrollment Agreement but before starting class.
3. After attendance has begun, The Center will retain the \$50 non-refundable supply fee, \$100 non-refundable registration fee plus the percent of program costs as follows:

4. Refunds will be made within 30 days of termination or receipt of Cancellation Notice.
5. An enrollee can be dismissed, at the discretion of the director, for insufficient progress, non-payment of program cost, or failure to comply with rules and regulations.
6. Students are considered enrolled regardless of attendance unless written notice of termination is mailed to the school with return receipt requested. An enrolled student will be provided a seat in all scheduled classes as well as supplies and make-up appropriate to the classes.

ATTENTION CHECK PROVIDER: If you provide a check, BARBIZON may convert your payments by check to an electronic automated clearinghouse (ACH) debit transaction. The debit transaction will appear on your bank statement, although your check will not be presented to your financial institution or returned to you. This ACH debit transaction will not enroll you in BARBIZON'S automatic debit process and will only occur each time a check is received. All disputes, controversies or claims arising out of or related to this Enrollment Agreement, the validity of this Enrollment Agreement, and the scope or validity of this agreement to arbitrate shall be submitted for arbitration to be administered by the American Arbitration Association ("AAA") on demand of either party. The arbitration proceeding shall be conducted in the city in which the Center is located before one (1) arbitrator. The obligation to arbitrate shall continue in full force and effect subsequent to and notwithstanding expiration or termination of this Agreement. The parties agree that this agreement to arbitrate is intended to be broadly interpreted and shall encompass, but not be limited to, claims based on contract, tort, statute, fraud, misrepresentation or any other legal theory, as well as claims that arose before the execution of the Agreement, including claims relating to advertising or promotional materials. Any arbitration under this Agreement will take place on an individual basis, and the parties agree that class arbitrations and class actions are not permitted. All matters relating to arbitration will be governed by the United States Federal Arbitration Act (9 U.S.C. §§ 1 et seq.). Judgment upon the arbitrator's award may be entered in any court of competent jurisdiction.

NOTICE TO BUYER: You may cancel this transaction at any time until midnight of the third business day after the date of the transaction but before attendance has begun. Cancellation must be made by certified mail sent to the above address. DO NOT SIGN THIS CONTRACT BEFORE YOU HAVE READ IT OR IF IT CONTAINS ANY BLANK SPACES. YOU ARE ENTITLED TO AN EXACT COPY OF THE CONTRACT YOU SIGN. KEEP IT TO PROTECT YOUR LEGAL RIGHTS.
