### **DESCRIPTION OF TRAINING TO BE PROVIDED AND THE BENEFITS OF THE TRAINING**

Through the Food Enzyme Institute series, the practitioner will learn how to effectively guide patients with unresolved health problems through their recovery back to optimal health. Practitioners will learn how to:

- Evaluate, work with and appropriately refer difficult and problematic cases.
- Evaluate the diet and determine the need to normalize food intake and eliminate food excesses.
- Recognize the need to enhance proper digestion and absorption of a balanced diet.
- Determine the need to normalize elimination and, when necessary, suggest methods of detoxification.
- Determine what organs or body systems have been nutritionally stressed.
- Provide guidance concerning appropriate nutritional support utilizing food enzymes and whole food sources of nutrients.
- Suggest what dietary and lifestyle changes may be needed to help reduce the individuals stress.
- Utilize a survey of the patient's signs and symptoms in conjunction with a personal interview to recognize the patient's needs.
- Incorporate 24-hour urinalysis results to recognize possible pathological processes and to suggest referral for appropriate medical care.
- Proper screening procedures for evaluating physical signs of stress and to recognize the need for referral for appropriate treatment.

After successful completion of all seminars and coursework, the student must complete an open-book exam. This includes evaluation and recommendations for three complete case studies and a question/answer exam. Upon satisfactory completion of the test, the student will then be awarded a diploma, designating the student as a Digestive Health Professional.

While this system teaches evaluation of stress and determination of appropriate nutritional treatment, it does not in any manner imply that a student is taught the diagnosis of disease. Additionally, each practitioner needs to be aware of their state's laws and regulations and practice within their own scope of practice. ### **ADMISSIONS PROCEDURE**

- Individuals who are interested may contact the Food Enzyme Institute to register for an account.

- To ensure a seat in the seminar, a student should pay for seminars 30 days in advance of attendance. This payment holds the student's place in the seminar.
- Student must purchase required text(s) and materials prior to attendance of seminar.
  - There is no application deadline for the program so students may apply throughout the year.

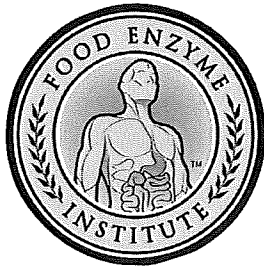
Tuition for seminars should be received at least 30 days in advance of the seminar. Required texts and materials can be purchased from the Institute.

## What We Do

The Food Enzyme Institute™ specializes in health care, not sick care. Our goal is to maintain the balance in the body that is necessary for optimal health through the use of diet and nutrition.

This concept was advocated by the United States Surgeon General, C. Everett Koop, in 1988. In his health and nutrition report to the American people, Dr. Koop emphasized that chronic degenerative diseases such as heart disease, stroke, cancer, and diabetes must be prevented because the search for cures is fruitless and the treatment and rehabilitation cost-prohibitive.

The Loomis System® advocates using whole food as a dietary mainstay in conjunction with exercise, adequate rest, clean air and water, and mental and emotional stability as a part of a total wellness program. While all health care experts recognize the validity of such an approach, few recognize the importance of proper digestion, absorption, assimilation, and elimination. Fortunately, we do and that is the Loomis System® difference.

The Loomis System® was developed to complement all methods of health care. It is a tool for locating, identifying, and eliminating or reducing stress (chemical, structural, emotional) in the body. We recognize that each body is biochemically unique, and therefore

we do not use the magic bullet approach to health care. Each body will tell you how stress is exhausting its normal functions and processes. It will even tell you how it is compensating for its inadequacies. It is then up to the practitioner to identify the stress in the patient's life and guide him or her through the correction and healing phases.

## How We Do It

We go to the source of stress to nourish the body rather than treat individual symptoms by temporarily covering up discomfort with medication. We use the basic sciences to understand how the body operates and to figure out what stresses are causing it to malfunction. The Loomis System® uses several diagnostic tools including a case history combined with physical examination and lab tests to determine the stress and how to eliminate or reduce its effects.

We recognize and focus on the importance of digestion and the role that enzymes play in it.

# Enzyme Nutrition

---

Enzyme nutrition is the art and science of using nutrition to maintain homeostasis and health in the body. It works with the body's innate intelligence to bring the body to optimal health using whole foods that contain protein, carbohydrates, fats, vitamins, minerals, and enzymes, rather than trying to manipulate it by using chemical compounds that produce side effects.

Food enzymes are a natural and important component in our food supply, yet they are systematically removed to extend shelf-life. While shelf-life is necessary in our modern society, enzymes must be replaced, just as vitamins and minerals are. For example, when milk is pasteurized it depletes the vitamin A and D content as well as enzymes. The vitamins are added back in, but the enzymes are not. Enzymes are the construction workers of the body. Protein, carbohydrates, fats, vitamins, and minerals are simply the building materials.

Optimal health can only be attained when each person is viewed as biochemically unique. Individuals cannot and should not be categorized or labeled to fit into a particular pharmaceutical paradigm. What is good for the general public is not necessarily good for the individual. Before recommendations are made for an individual, specific biochemical and mechanical needs must be objectively ascertained and not subjectively surmised.

We use proven and time-honored standards to nutritionally support the body. We recognize that the best sources of nutrients are not concentrated chemical compounds but whole foods with contents that act synergistically when properly digested and assimilated.

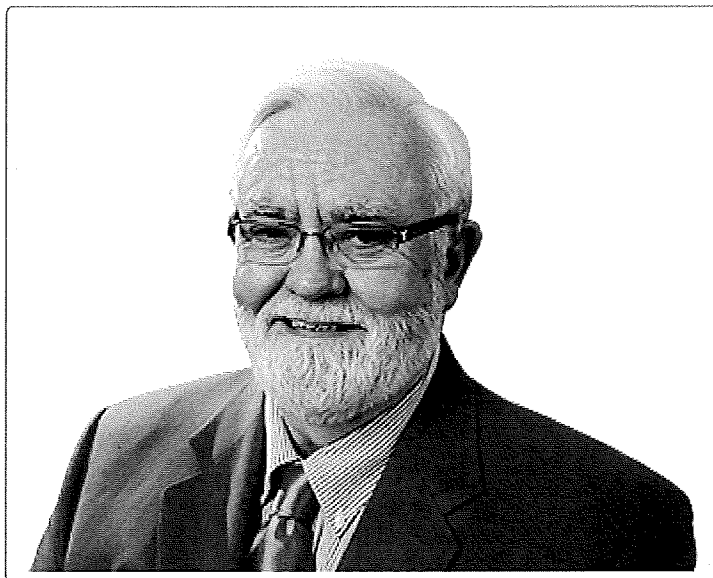

**Howard F. Loomis Jr., D.C., F.I.A.C.A.**

President, Food Enzyme Institute Director

Howard F. Loomis, Jr., DC, a second-generation chiropractor, graduated from Logan Chiropractic College in 1967. Upon graduation he began a practice in Missouri that he built around the same belief that his father held in his practice, that digestion was the place to begin healing and maintain health. At the time, Dr. Loomis used traditional

digestive supplements such as HCl and pancreatin (animal enzymes), just as his father had used. By 1979 he gave up in frustration because the products failed to yield consistent results.

Dr. Loomis's interest in nutritional food enzymes began in 1980 when he had the opportunity to bring the theoretical work of Edward Howell, MD, the food enzyme pioneer, into the clinic. Dr. Loomis spent years in the clinic developing a system for correctly identifying nutritional deficiencies in the body. His system, the Loomis System® is now recognized as a legitimate and proven method of determining nutritional stresses on the body.

In 1985, he began lecturing nationally and internationally on the benefits of plant enzymes. The following year, in addition to running his practice in Missouri, he founded 21st Century Nutrition® for the sole purpose of educating professionals on the clinical usage of enzymes. In 1993 he sold his practice and moved his company, 21st Century Nutrition, to Madison, Wisconsin, where he founded the enzyme supplement company, Enzyme Formulations®, Inc. In 2002, 21st Century Nutrition became known as the Loomis Institute™ of Enzyme Nutrition and earned recognition by the State of Wisconsin Approval Board as a post graduate school. The Loomis Institute changed its name to the Food Enzyme Institute™ and continues to be approved by the State of Wisconsin Educational Approval Board.

Thousands of health care professionals have been educated by the Institute, and the number continues to grow. Today the Food Enzyme Institute teaches seminars on enzyme nutrition nationwide and holds an annual Enzyme Nutrition Conference.

Dr. Loomis' extensive knowledge of physiology, biochemistry, and enzymology has made him a sought-after speaker and a prolific writer. Dr. Loomis published *ENZYMES: The Key to Health* in 1999, as well as *The Enzyme Advantage: For Healthcare Providers and People Who Care About Their Health*, with medical Journalist Arnold Mann, in 2015. 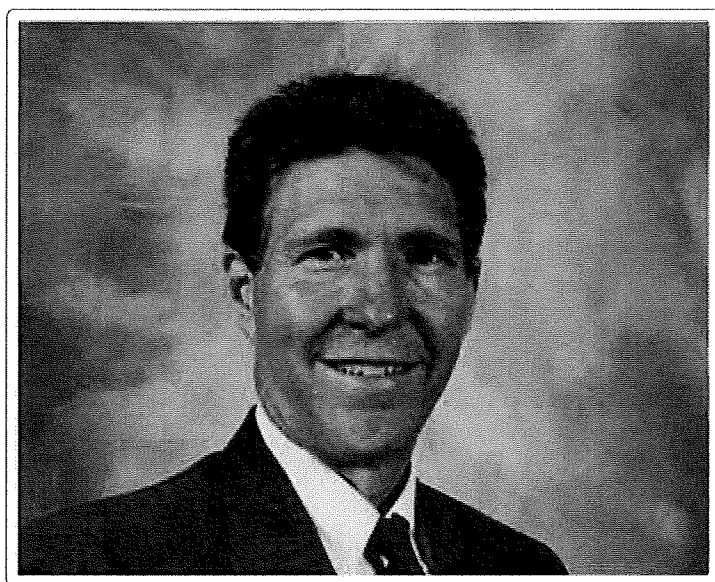

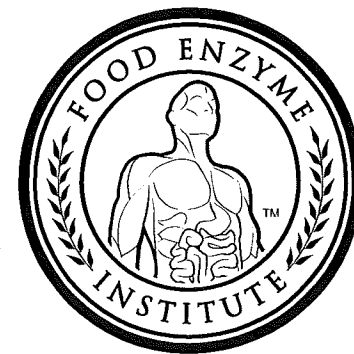
