On July 29th, 2004, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") suspending Respondent's professional nursing license for an indefinite period. Respondent has been granted a stay of suspension and her license is currently limited with certain terms and conditions.

On March 14, 2019, the Board considered Respondent's request for the return of full licensure or a reduction in drug screens. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Respondent's request for the return of her professional nursing license (#68922-30) to full, unrestricted status or a reduction in drug screens is hereby DENIED due to insufficient time in continuous compliance with the Board Order (07/29/2004).

2. This order is effective the date of its signing.
