On October 4, 2007, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") suspending Respondent's professional nursing license for an indefinite period. Respondent has been granted a stay of suspension and his license is currently limited with certain terms and conditions.

Information has been received that demonstrates Respondent is in violation of the terms of the Order and, as a result, the following is entered:

<u>ORDER</u>

- 1. The stay of suspension is removed and Respondent's professional nursing license (#115740-30) is hereby SUSPENDED until further notice.
- 2. Respondent may petition for reinstatement of the stay upon providing proof, determined by the Board or designee to be sufficient, that Respondent is in compliance with sections C and D of the Order.
 - 3. This order is effective immediately.
