

## **Historical Account of Radiant Living and Approvals**

The Radiant Living Online School of Ayurveda was the first Ayurveda school that was approved by the Texas Workforce Commission. The purpose of the school is to train those who are embarking on a career to practice the healing system of Ayurveda. You are among the pioneers in the world to bring this ancient knowledge and science from India into your homes and communities. Radiant Living is dedicated to providing students with top notch Ayurvedic education.

Radiant Living began offering training for Ayurvedic Health Counselors (AHC) in January 2015. This program consists of 12 modules plus an internship, and focuses on the philosophy and fundamental principles of Ayurveda. As of this writing, the second AHC training coursework ended in September of 2017 and one student has received her AHC certification and the other interns are currently working on their AHC internship. Another AHC group began in October 2017. The next AHC course starts on September 4, 2018.

Radiant Living also offers training for certification as an Ayurvedic Practitioner. The first group of AP students had coursework from February 2016-February 2017 and three students completed their AP internship in August of 2017. Two more students initiated their AP coursework in January 2018 and the next AP group begins in January 2019. The AP program consists of 12 modules plus an internship and focuses on the clinical application/disease management of Ayurveda.

The school director reserves the discretion to wait any number of months to restart an additional year two program until a sufficient number of students are ready to begin year two studies. There is an estimated three to six months break in between year one and year two to allow AHC interns to complete most, if not all, of their year one internship requirements (50 supervised patient encounters) before starting year two coursework. Ayurvedic Health Counselors who wish to continue to year two directly after their year one are responsible for finding a school that will accept their year one credentials should Radiant Living not offer it in the student's desired timing. Students may opt to delay year two training by one year or more and then join a subsequent group.

Radiant Living's programs meet the highest of national standards in the U.S. set by the National Ayurvedic Medical Association (NAMA) and and the Association of Ayurvedic Professionals in North America (AAPNA). Radiant Living has been approved by and is an Organizational Member of both NAMA and AAPNA.

## The Radiant Living Mission Statement

Director Patricia Wickman's vision is to sustain a vibrant online community space where Ayurvedic experts and students gather from all over the world to learn about Ayurveda and train to be Certified Ayurvedic Health Counselors and Practitioners. The Director is enthusiastic about getting this knowledge and wisdom into the hands of moms, grandmas, dads, grandpas, youth, etc. so that families and communities will learn how to take care of themselves, their children and aging parents through means such as nutrition, exercise, positive lifestyle choices, yoga, breath techniques, meditation, herbal medicine and more. As we pass along these nourishing traditions we can address global problems and promote healthy, peaceful and conscious living. The Dalai Lama said, "If every eight-year-old in the world is taught meditation, we will eliminate violence from the world within one generation." ## **Creative Instruction and Varied Modern Teaching Methods**

Classes will be creative, interactive, lively, diverse, student-centered, practical and case-based. In addition to the curriculum outlined by the National Ayurvedic Medical Association, we have a "Lite" version of the school for purchase that includes instruction on how to incorporate Ayurveda into daily living such as cooking demonstrations, daily routine tutorials, recipes, recorded guided meditations, seasonal cleanse instructions, etc. Trainees in the full version have lifetime access to all of the Lite version materials.

## **Guest Faculty**

One of the most exciting components of the online format is that we invite expert guest speakers into our virtual classroom to give presentations on their area of specialty. Students have the opportunity to ask questions and learn from a diverse group of fantastic presenters including teachers who received their BAMS degree (Bachelor of Ayurvedic Medicine and Surgery) in India. The schooling for this is similar to Medical Doctors in the United States. BAMS coursework is five-and-a-half years followed by a minimum of a one-year internship.

## **Benefits of Online Learning**

- Eliminates travel time and the expense of gasoline, flights and hotels
- Reduces or eliminates the cost of pet, house and/or babysitters

- Provides for a flexible study schedule
- Students can work at their own pace
- Minimally interferes with work schedules and family time
- Allows for shorter class periods. In the typical Ayurvedic training, class time includes Friday evening and all day Saturday and Sunday once a month. These intensive and concentrated classes can be fatiguing and overwhelming

- Enables creative instruction methods including easy video and document sharing, web browsing, supplemental audio presentations, engaging slide presentations, etc.

## AHC Program Description – Begins on Tuesday, September 4, 2018

Our Year One Ayurveda Health Counselor program consists of a total of 12 modules and gives students a thorough understanding of basic Ayurvedic concepts followed by a supervised internship program. The approval process (including the internship) takes a minimum of 52 weeks (1 year) and maximum of 104 weeks (2 years) to complete including the internship. If a student goes beyond the 2 year mark, he or she is required to pay an \$800 extension fee per year to the school. Successful completion of Level One prepares students to provide basic Ayurvedic counseling, take detailed current and past personal and family health history, determine the causes of imbalance, assess the physical and mental constitution and current state of health using Ayurvedic diagnostic methods. The Ayurvedic Health Counselor will provide public education regarding basic tenets of Ayurveda and recommend specific foods, lifestyle practices,

daily routines, herbs, yoga, self-care strategies, etc. that pertain to individual clients. AHC's refer clients to a Certified Ayurvedic Practitioner (CAP) for disease management with advanced herbal recommendations, panchakarma, yoga therapy, etc. The Radiant Living Online School of Ayurveda offers a certification (vocational credits) and does not award a degree to students who complete the program. Graduates benefit from additional education in entrepreneurship/business training as the majority of practitioners form their own private practice or join a group of holistic practitioners in other fields such as Chiropractic, Reiki, Massage, Acupuncture, etc.

## Year One Admission Requirements and Advanced Standing

Students must have a high school diploma or the equivalent. Some exceptions may apply for high school students who demonstrate the maturity to complete the requirements of the school. Students must be fluent in verbal and written English. There is no minimum age for applicants. There is no entrance test for the Radiant Living Online School of Ayurveda. Students must have reliable internet access in order to participate in the virtual classroom, keep up with class communications and have adequate access to research and study resources. Students must have basic computer skills including word processing. Students may attend Patricia's online classes in advance of the start of AHC classes to practice using the virtual classroom technology. In order to transfer from another Ayurvedic school and receive credits, the previous school has to be approved by the National Ayurvedic Medical Association. In order to receive advanced standing, the student must provide transcripts from the previous school with contact information for the school director. Radiant Living will

determine whether or not advanced standing will be granted based on Radiant Living's curriculum modules and approximate hours compared to the previous school. The program length and cost will be determined on a student-by-student basis. Tuition for students with advanced standing will be prorated based on the modules they attend with Radiant Living.

#### **AHC INTERNSHIP**

#### **Scope of Practice**

The scope of practice of Ayurvedic Health Counselors and interns, as establish by the National Ayurvedic Medical Association, includes the ability to evaluate the patient's constitution, current state of health and current imbalance (prakriti, vikruti and clinical vikruti) and focus on the prevention of disease by recommending proper dietary and lifestyle changes. Interns formulate spice mixes and personalized herbal tea blends to enhance the digestive system of their clients. Counselors are trained to confidently provide a Report of Findings to clients and to provide follow-up care. AHC candidates are required to complete a minimum of 50 supervised (either directly or indirectly) patient encounters – 25 of which are observations and 25 of which are facilitated by the intern herself.

#### **Unique Intern Online Opportunities**

Because Radiant Living has a naturally built-in online forum, the school provides students with the unique opportunity to observe and participate in cyber appointments from the outset of their coursework. Upon client consent, school Director, Patricia Wickman as well as current and past interns and students, invite new students to join them in the online classroom for either live broadcasts or online appointments. As the future of western medical appointment is online, so too is the future of Ayurvedic consultations. As a result, AHCs can broaden their reach to include clients in other parts of the country as well as develop an international clientele. The possibilities are endless and promise to benefit our entire planet as individuals become more capable of caring for themselves and their friends and family through preventive medicine!

#### **Extension Fee for Internship**

The deadline for completion of the internship is one year after the last month of the AHC internship. If the internship minimum requirements are not met within 12 months after the last month of coursework, interns must pay an additional \$800 extension fee per year.

At present, there are two different program options for intern clients.

- 1. Guardian Angel Program (GAP) Four Appointment Package \$275 up-front charged to the client. This includes a 1.5 to 2-hour intake appointment, a planning session for the client's program, a 1-hour "Report of Findings" appointment, two 1-hour follow-up appointments and a month's worth of a personalized tea and spice mix.
  - a. From the start of class, interns are encouraged to spread the news that they are in the Radiant Living Ayurvedic certification program. They explain how the appointments work and recruit friends, family and other

- willing people to participate in one of the two programs offered by the school.
- b. Students start observing patient encounters at the outset of the school year to fulfill 25 observation patient encounters. The majority of Patricia's appointments are conducted during regular business hours. They sometimes are online with clients and sometimes in-person. We recognize that most of you have busy daytime schedules and will seek the permission of the client to record the appointments so you can watch them after-the-fact. If the intern(s) cannot attend live, they must record notes and observations in the client forms to demonstrate active interaction with the recording. Approximately two times a month, patient encounters will be scheduled on a weekday evening. Planning sessions for client Ayurvedic programs also count as patients encounter and are referred to as "Rogi Reviews" on the school Google calendar.
- c. Toward the end of the school year and during the official internship period after Year One coursework has ended, "advanced" interns are encouraged to "fly the coop" and experiment with their fledgling wings by conducting appointments without the presence of Patricia or any mentor in order to complete the 25 facilitated patient encounters.
- d. Advanced interns may choose from any of Radiant Living's internship supervisors throughout the 4-appointment basic counseling package. As soon as a client schedules, the intern schedules a mentorship session that occurs <u>after</u> the intern has done her best to complete the report of findings on her own.
- e. For seasoned interns only (Patricia will attend these sessions during the early days of coursework): The intern(s) meet in between the first two appointments to create the client's Report of Findings which includes formulations for a personalized herbal tea and spice mix. This planning session can take three hours or longer in some cases. If only the intern in charge can meet for this planning session, he/she is solely responsible for preparing the plan. Clients may choose to quietly listen in on this planning session.
- f. The intern(s) then has/have their appointment with their mentor (after the intern(s) has/have completed as much of the Report of Findings as possible. The intern will make note of specific questions to ask the mentor so that the time spent with the mentor is efficient and kept to no longer than 1 hour. Clients may choose to quietly listen in on this planning session.
- g. The ROF planning session counts as a Patient Encounter. One advanced intern or Patricia will facilitate for a facilitator credit and the others will receive an observation Patient Encounter. Interns are to keep a separate log of these patient encounters with a record of the date and type of appointment. Note that it is beyond the scope of practice for an AHC to create Ayurvedic herbal formulas. If the client indications that they would like a formula, this must be done by a Certified Ayurvedic Practitioner.

- h. The intern then conducts the Report of Findings appointment.
- i. 2 follow-up visits remain and if questions arise that the intern can't answer, she may call her mentor with questions—each call to be kept to no longer than 10 minutes. Interns can also send questions via email. Please be respectful of the mentor's time and avoid unnecessary conversation unless initiated by the mentor.
- j. If the intern is an observer for these appointments he/she is to write observations, insights, questions and comments at the end of the client's forms and label them with the date and the intern's name. The observers are expected to be active/interactive and not passive learners during observation Patient Encounters.
- k. Interns are required to both formulate and mix one-month's worth of personalized tea blend and spice mix which is included in the portion of the fee retained by the intern. The intern gives or ships these herbs at the time of the Report of Findings.

#### 2. The Guardian Angel Program (GAP) Three-Month Option

- a. Clients sign up for three months (12 weeks) of appointments. The first two appointments (plus the in-between session for ROF planning) are the same as the \$275 basic package. The 10 follow-up visits are either weekly for 30 minutes or 1 hour when the client chooses to have appointments every two weeks. Interns will be given the opportunity to both observe and facilitate these appointments.
- b. Following is how payment will be handled for the Guardian Angel program:
  - i. If the client registers for the health coach program through Radiant Living and the intern(s) is an <u>observer</u> during the appointments, they will not receive payment for the appointments.
  - ii. If an intern finds a client to sign up for the program and is an observer during the online appointments, they will receive a \$100 finders fee and the rest of the payment goes to the Radiant Living Online School of Ayurveda.
  - iii. If an intern (this only applies to advanced interns who need little supervision) finds the client and is a <u>facilitator</u> for these appointments, the school will retain \$200 and the intern will receive the rest of the fee.
  - iv. If Radiant Living finds the client and the intern is a <u>facilitator</u>, the intern will receive \$200 from the total client payment.

## **AP Program Description**

The Year Two Ayurvedic Practitioner program consists of a total of 13 modules and gives students a thorough understanding of clinical Ayurvedic Medicine followed by an internship program focusing on application of clinical Ayurvedic principles. The approval process (including the internship) takes a minimum of 78 weeks (1.5 years) and maximum of 104 weeks (2 years) to complete including the internship. There are 10 academic class modules followed by 2 internship class modules. The 13th module is the internship. Successful completion of Year Two prepares students to clinically analyze each client through the lens of Ayurvedic medicine with regards to the digestive, nervous, endocrine, immune, respiratory, urinary cardiovascular, women's reproductive, men's reproductive systems, etc. This additional training prepares practitioners to understand pathology and disease management beyond that of the Ayurvedic Health Counselor. Practitioners also practice health promotion by preparing custom-fit Ayurvedic dietary and lifestyle programs, detox and rejuvenation plans and herbal formulas for their clients. *Practitioners who wish to be certified to administer panchakarma body therapies will need to register for the Certified Ayurvedic Bodywork Therapist program* 

which is separate from both the AHC and AP programs. The Radiant Living Online School of Ayurveda offers a certification (vocational credits) and does not award a degree to students who complete the program.

## **AP Admission Requirements and Advanced Standing**

To begin the Ayurvedic Practitioner coursework, students must have the equivalent of an Ayurvedic Health Counselor Certification from an Ayurvedic school that is approved by the National Ayurvedic Medical Association. If a student would like to transfer from another ayurvedic school and has not yet completed an AHC internship, the student will need to do that with a Radiant Living supervisor concurrently while doing the Ayurvedic Practitioner course work. In order to receive advanced standing, the student must provide transcripts from their previous school with contact information for the school director. Radiant Living will determine whether or not advanced standing will be granted based on Radiant Living's curriculum modules and approximate hours compared to the previous school. If a student has already completed partial Ayurvedic Practitioner studies at a previous school and wishes to transfer mid-year, the program length and cost will be determined on a student-by-student basis. Tuition for students with advanced standing will be prorated based on the modules they attend with Radiant Living. Students must also have a high school diploma or the equivalent and be fluent in verbal and written English. There is no minimum age for applicants. There is no entrance test for the Radiant Living Online School of Ayurveda. A personal interview will be conducted with each student prior to acceptance as part of our selection criteria. Students must have reliable internet access in order to participate in the virtual classroom, keep up with class communications and have adequate access to research and study resources. Students must have basic computer skills including word processing. Patricia will hold training sessions in advance of the start of classes to make sure students understand how to use the virtual classroom technology.

#### **AP Internship**

The Certified Ayurvedic Practitioner Internship consists of 100 patient encounters *in addition to* the 50 AHC internship PEs. 50 of these encounters are observation and 50 intern-facilitated encounters with either direct or indirect supervision. Patient encounters will occur throughout the school year and interns are given a maximum of 12 months after coursework has ended to complete the internship. After the intern(s) has completed the minimum number of patient visits, they may practice privately as an Ayurvedic Practitioner. The same details for the AHC internship apply to the AP internship. #### **Academic Policies**

#### Homework and Assessments

- 1. All homework assignments must be complete and submitted to the instructor by the end of the course in order to receive certification.
- 2. Students must have an additional copy of all homework available during the live web classes.
- 3. Homework is graded on a pass/fail basis. Homework that is complete, correct, turned in on time and showing integration of Ayurvedic concepts will receive a passing grade. Incomplete or incorrect work will receive a failing grade, but the student will have the opportunity to make corrections or complete an additional assignment in order to receive a passing grade upon approval of the instructor.
- 4. Any corrected homework or additional assignments must be submitted by the end of the course in order to receive certification.
- 5. All homework assignments must be complete with a passing grade.
- 6. Students should expect a minimum of approximately seven hours of study time per week to complete required reading and homework assignments.

#### Tests

- 1. Students will take a test at the end of each module.
- 7. Test are graded on a percentage basis. If a student receives a failing grade (below 60%), they will have the opportunity to retake the test to receive a passing grade. Students must notify the instructor via email when the retake of the test is complete.

#### **Progress Reporting**

1. Grades will be updated weekly and available for private viewing on Canvas. Most assignments are pass/fail. All Canvas assignments must be marked as complete in order to receive the AHC certification.

## **Class Participation**

- 1. Students must have complete homework assignments, textbooks, and supplemental materials with them for each live web class.
- 8. Students must be prepared to discuss the required reading materials during class.
- 9. Students must be ready to connect to the live class at least 10 minutes before the session begins to allow time for resolving any potential technical issues.
- 10. Students who enter the class late or leaving early must submit notes for missed time via Google Docs. Additional assignments may be given for the student to receive a passing grade at the discretion of the instructor.

## **Application Procedure**

## **Required Technology for Online Classroom**

All students are required to have a computer and good internet connection in order to participate in the live webcasts. A poor internet connection can result in sound and video delays. The room in which the student participates in the live webcasts needs privacy so class time is not disrupted by family members, pets, cell phones, etc.

## Leave of Absence, Refunds, Cancellations and Withdrawals

If illness or other serious circumstances occur that prevent a student from continuing the program as originally planned, the student may either withdraw from the program or apply for a leave of absence. For both alternatives, the student needs to obtain an application form from the administrative office and return it for approval. A leave of absence or a voluntary withdrawal with a pro rata refund will not officially begin until the Director of Radiant Living has been *notified in writing* (this provision does not apply to residents of Wisconsin). For Wisconsin residents only: If a student stops attending class and participating in homework *for a period of 6 months*, he or she will automatically be dismissed and issued a pro rata refund based on their last recorded date of attendance or any activity in the program. Non-Wisconsin residents must notify the Director in writing in order to receive a refund. Refunds for non-Wisconsin residents are based on the last recorded date of any sort of participation in the program.

Under Texas Education Code, Section 132.061(f), a student who is obligated for the full tuition may request a grade of "incomplete" if the student withdraws for an appropriate reason unrelated to the student's academic status. A student receiving a grade of incomplete may reenroll in the program during the 12-month period following the date of the student's withdrawal and complete those incomplete subjects without payment of additional tuition. In other words, a student may resume attending classes during the next school year at the level where the leave was initiated at no additional cost if the student paid in full at the beginning. The exception to this is if the course of instruction is discontinued by the school and this prevents the student from completing the course (See 7b of "Refund Policy"). The student also has the option of viewing recordings from their own school year and completing the assignments through independent study. To resume the program, a student must notify Radiant Living's Director of his or her intention to resume classes and be in good academic and financial standing. It is not necessary for a student to retake any previously completed classes if the course of study resumes within twelve months of beginning the leave of absence.

During a leave the student may make arrangements for a payment plan interruption. The student will need to apply for readmission to a new class at the tuition rate in effect at that time. This is also the case if a student chooses to withdraw. (See "Refund Policy").

There will be no refunds or credits for missed classes during the program. Tuition and fees are based upon a student's reservation and intent to attend.

#### **CANCELLATION POLICY**

A full refund will be made to any student who cancels the enrollment contract within 72 hours (until midnight of the third day excluding Saturdays, Sundays and legal holidays) after the enrollment contract is signed. A full refund will also be made to any student who cancels enrollment within the student's first three scheduled class days, except that the school may retain not more than \$100 in any administrative fees charged, as well as items of extra expense that are necessary for the portion of the program attended and stated separately on the enrollment agreement. For Wisconsin residents: A full refund will be made within 10 business days after the cancellation.

#### REFUND POLICY FOR NON-WISCONSIN RESIDENTS

The following refund policy is in compliance with requirements established by the Texas Workforce Commission and does not apply to Wisconsin residents.

- 1. Refund computations will be based on scheduled course time of class attendance through the last date of attendance. Leaves of absence, suspensions and school holidays will not be counted as part of the scheduled class attendance.
- 2. The effective date of termination for refund purposes will be the earliest of the following:
  - (a) The last day of attendance, if the student is terminated by the school;
  - (a) The date of receipt of written notice from the student; or
  - (b) Ten school days following the last date of attendance.
- 3. If tuition and fees are collected in advance of entrance, and if after expiration of the 72 hour cancellation privilege the student does not enter school, not more than \$100 in any administrative fees charged shall be retained by the school for the entire residence program or synchronous distance education course.
- 4. If a student enters this synchronous distance education program and withdraws or is otherwise terminated after the cancellation period, the school or college may retain not more than \$100 in any administrative fees charged for the entire program. The minimum refund of the remaining tuition and fees will be the pro rata

portion of tuition, fees, and other charges that the number of hours remaining in the portion of the course or program for which the student has been charged after the effective date of termination bears to the total number of hours in the portion of the course or program for which the student has been charged, except that a student may not collect a refund if the student has completed **75 percent or more** of the total number of hours in the portion of the program for which the student has been charged on the effective date of termination. More simply, the refund is based on the precise number of course time hours the student has paid for, but not yet used, at the point of termination, up to the 75% completion mark, after which no refund is due.

- 5. Refunds for items of extra expense to the student, such as books, tools, or other supplies are to be handled separately from refund of tuition and other academic fees. The student will not be required to purchase instructional supplies, books and tools until such time as these materials are required. Once these materials are purchased, no refund will be made. For full refunds, the school can withhold costs for these types of items from the refund as long as they were necessary for the portion of the program attended and separately stated in the enrollment agreement. Any such items not required for the portion of the program attended must be included in the refund.
- 6. A student who withdraws for a reason unrelated to the student's academic status after the 75 percent completion mark and requests a grade at the time of withdrawal shall be given a grade of "incomplete" and permitted to re-enroll in the course or program during the 12-month period following the date the student withdrew without payment of additional tuition for that portion of the course or program.
- 7. A full refund of all tuition and fees is due and refundable in each of the following cases:
  - (a) An enrollee is not accepted by the school;
  - (c) If the course of instruction is discontinued by the school and this prevents the student from completing the course; or
  - (d) If the student's enrollment was procured as a result of any misrepresentation in advertising, promotional materials of the school, or representations by the owner or representatives of the school.

A full or partial refund may also be due in other circumstances of program deficiencies or violations of requirements for career schools and colleges.

#### REFUND POLICY FOR STUDENTS CALLED TO ACTIVE MILITARY SERVICE

A student of the school or college who withdraws from the school or college as a result of the student being called to active duty in a military service of the United States or the Texas National Guard may elect one of the following options for each program in which the student is enrolled:

- (a) If tuition and fees are collected in advance of the withdrawal, a pro rata refund of any tuition, fees, or other charges paid by the student for the program and a cancellation of any unpaid tuition, fees, or other charges owed by the student for the portion of the program the student does not complete following withdrawal:
- (e) A grade of incomplete with the designation "withdrawn-military" for the courses in the program, other than courses for which the student has previously received a grade on the student's transcript, and the right to reenroll in the program, or a substantially equivalent program if that program is no longer available, not later than the first anniversary of the date the student is discharged from active military duty without payment of additional tuition, fees, or other charges for the program other than any previously unpaid balance of the original tuition, fees, and charges for books for the program; or
- (f) The assignment of an appropriate final grade or credit for the courses in the program, but only if the instructor or instructors of the program determine that the student has:
  - Satisfactorily completed at least 90 percent of the required coursework for the program; and
  - 1. Demonstrated sufficient mastery of the program material to receive credit for completing the program.

The payment of refunds will be totally completed such that the refund instrument has been negotiated or credited into the proper account(s), within **60 days** after the effective date of termination.

#### REFUND POLICY FOR WISCONSIN RESIDENTS

- 1. The student will receive a full refund of all money paid if the student:
  - (a) Cancels within the three-business-day cancellation period under EAB 6.04;
  - (b) Was unqualified and the school did not secure a disclaimer under EAB 9.0;
  - (c) Enrollment was procured as the result of any misrepresentation in the written materials used by the school or in oral representations made by or on behalf of the school.
- 2. Refunds will be made within 10 business days of cancellation.

3. A student who withdraws or is dismissed after attending at least one class, **but before completing 60**% of the instruction in the current enrollment period, is entitled to a pro rata refund as follows:

- 4. As part of this policy, the school may retain a one-time application fee of no more than \$100. The school will make every effort to refund prepaid amounts for books, supplies and other charges. A student will receive the refund within **40 days** of termination date. If a student withdraws after completing 60% of the instruction, and withdrawal is due to mitigating circumstances beyond the student's control, the school may refund a pro rata amount.
- 5. A written notice of withdrawal is **not** required.

## **Scholarships**

Radiant Living does not offer scholarships nor bartering for services. Students may choose to obtain a private student loan or run a crowdsourcing campaign to raise funds for their studies. The school directer is happy to provide guidance on how to run a successful crowdsourcing campaign. Where there is a will to study Ayurveda, there is a way!

## **Attendance, Tardiness and Leaves**

1. Each module/month consists of approximately 12 hours of live class time. If the student misses a class, he or she must view the recordings of class and provide the instructor with notes on the class to demonstrate that he or she has viewed it. Students must notify the school director ahead of the class period if they are going to miss class in order for it to be an excused absence. More than 5 unexcused absences are grounds for student probation. <sup>1</sup> See "Probation, Dismissal and

- Re-admittance." Students will not receive approval as an AHC or AP until the missed classes and all assignments are complete. This is in accordance with the National Ayurvedic Medical Association's requirement that students participate in live instruction. Attendance is recorded in the online Canvas classroom.
- 11. Students who arrive to class more than 30 minutes late or who leave class more than 30 minutes early are considered tardy for the class, unless excused by the instructor. Each 3 tardy's counts as one absence. He or she must watch the recording of the missed portion and present notes to the instructor. Students are expected to arrive in the online classroom on time.

#### Other Assistance

- 1. Students are welcome to contact the instructor at any time via email with questions about homework, class concepts, etc. Please do not hesitate to ask for help when it is needed.
- 12. Students are encouraged to connect with a study-buddies. This are people that you talk with over the phone or online to discuss integration of Ayurvedic concepts and to help each other with homework assignments.
- 13. If a student is having extreme difficulty with academic material/concepts that cannot be answered adequately via email or by engaging other students in conversation, the student may request a private phone tutorial with an instructor at the cost of \$60/hr.

## **Progress Records and Grades**

All grades/progress records are accessible in the Canvas classroom. Assignments are complete or incomplete. Quizzes and tests are electronically scored in the Canvas classroom. At the end of Module 10, If the student does not have a grade of at least and 80% in the classroom the instructor will schedule a meeting to create a plan with the student regarding how they can become raise their grade. Students need to complete all of the assignments, quizzes and tests in order to graduate from the Radiant Living Online School of Ayurveda. They must retake the quizzes and tests until they receive a score of 80% or higher. Students are required to take and pass the National Ayurvedic Medical Association (NAMA) board exams in order to receive recognition through this organization of official qualification as a Certified Ayurvedic Health Counselor and/or Certified Ayurvedic Practitioner.

All student records for the Radiant Living Online School of Ayurveda are permanently stored electronically by the school. Student transcripts will be kept permanently. Radiant Living maintains confidentiality of all records by using password-protected technology when sharing them with students. Should there be a technology glitch in Canvas, GoToMeeting and Google Drive, Radiant Living will not be held responsible.

recorded and the student will submit notes he has taken via Google Drive in order to receive credit having attended class.

#### **Code of Student Conduct**

Students are expected to think, act and live in accordance with the laws and spirit of Ayurveda & Yoga, their own dharma, and ahimsa. All students must follow the national standards of practice and conduct established by the National Association of Ayurvedic Medicine, the Yoga Alliance, and all policies of Radiant Living.

Specific expectations to study, live and practice within this spirit are:

- Students should be punctual for class and appointments. Repeat tardiness is not acceptable.
- The room in which you are participating in the live web classes should be private and as free of disturbances from family members and pets as possible.
- Classroom attire shall be modest, neat and clean.
- Whenever working with the public or clients, please refrain from wearing scented perfumes or chemicals, in respect for those with chemical sensitivities.
- Please turn off all cell phones, alarms, audio pagers and similar equipment before the start of the live web classes.
- In emailing and calling Radiant Living's administration and instructors, be respectful of their personal and family time.
- Please follow each instructor's direction for asking questions during class. It is desirable to stay on subject and limit other questions to designated times. The instructor has an office hour on Wednesdays from 10-11am CDT to address individual needs.
- Students promise to embrace and love themselves and their teachers despite their shortcomings and submit to the Japanese concept of "Wabi-sabi" or that beauty is found in the transient and imperfect nature of everything in nature and life. Students understand that any grievances must be shared with the school director IN PRIVATE and not during group classes. Complaints must be communicated in a civilized and cultured manner.

In the event a student's conduct or intended conduct is not conducive to his or her learning or the learning of others, the director shall communicate these concerns to the student and jointly suggest a plan of corrective action within a specified time period. If, after the specified time, the director feels the student has not adequately responded, the director and student should meet to determine further action (see "Probation, Dismissal and Re-admittance").

## **Probation, Dismissal and Re-admittance**

A student who fails to meet academic standards or who violates the code of conduct will be placed on probationary status after meeting with the director. The duration of the probation is one month. If the student has failed to meet academic requirements

when the probationary period expires, the student may be dismissed from the school. Students may appeal the dismissal by writing a letter to the director. Re-admittance will only be considered in extreme circumstances at the discretion of the director. Under Title 40, Texas Administrative Code, section 807.221-224, students terminated for unsatisfactory progress cannot be readmitted until a minimum of one grading class period.

#### **Grievance Procedure**

Radiant Living Online School of Ayurveda has a certificate of approval from the Texas Workforce Commission to operate a career school or college in the state of Texas. In addition, the school has a certificate of approval by the Educational Approval Board in the state of Wisconsin. The assigned school number in Texas is S4684. Both the AHC and AP programs are approved by the TWC, other Texas state agencies, the Wisconsin Educational Approval Board and the National Ayurvedic Medical Association (NAMA). Students must address their concerns about the school or an educational program by following this grievance process: If a student has a complaint about Radiant Living or any of its faculty or representatives, the student should first attempt to communicate his/her concerns with the party involved. Such issues typically serve as a learning process for all involved. If the complaint or concern is not resolved at that level, the school Director should be contacted for further action. If the complaint cannot be resolved after exhausting the school's grievance procedure, the student may file a formal complaint with TWC. ## Ayurveda Certificates & Graduation

At the completion of the Ayurveda Health Counselor coursework and internship, all students who have successfully finished the entire program in good academic standing and have all tuition and fees paid in full are granted a certificate as an Ayurvedic Health

Counselor. There will be an online graduation ceremony for students who complete all requirements. Students will become board certified by the National Ayurvedic Medical Association upon successfully passing the board exam. ## Auditing

Students who have completed any program and wish to repeat any portion thereof may request special auditing approval from the current instructor at no additional cost. Advanced students are encouraged to keep attending classes to assist in the capacity of mentors and cheerleaders for the less seasoned students. Also, this will foster a Radiant Living community of support with like-minded people. Students wishing to enter on an auditing basis may do so for the AHC and AP programs if tuition for both programs has been paid in past years. Regular tuition, fees and all policies except grading and attendance apply.

## **Publicity/Advertising Rights**

The School reserves the right to photograph or video students and reproduce those photographs or videos in school literature, publicity, and/or advertising. #### **Graduate Placement Assistance**

The Ayurveda and Yoga professions in the U.S. are growing rapidly, but its non-licensed status still makes current graduates pioneers in the field. Most graduates nation-wide opt to begin private practice or join an existing practice. Some graduates may be hired by other clinics or wellness centers operating under the direction of a medical physician, chiropractor, massage therapist, or other licensed professional looking to add an Ayurveda or Yoga program to their repertoire. There is a Facebook page for Ayurvedic Practitioners where people post new job openings or practices for sale on a regular basis. Radiant Living makes an effort to stay apprised of job openings and career opportunities nation-wide, and to pass that information on to our students and graduates via email or Facebook. Radiant Living does not offer formal placement services and makes no guarantee of employment. Upon request and written authorization from any student, the school will release a copy of the student's grades and faculty evaluation to other schools, potential employers or the student. Applicable administrative fees for processing may apply. The National Ayurvedic Medical Association is taking steps toward making Ayurveda a licensed profession in the United States. The details of requirements for licensure are unknown at this time, but there are plans for a grandfathering process for Ayurvedists who have pursued studies prior to the instigation of licensure. Radiant Living's school director will do her best to stay abreast of licensing issues and notify the students. Students are encouraged to learn about such developments on their own as well. The Radiant Living Online School

of Ayurveda does not guarantee employment. Student referrals to prospective employers are not based on direct contact with the employer regarding current job openings.

## **Space Description, Facilities and Equipment**

Radiant Living is an online school. Live classes will be broadcast from an office in Helotes, TX. The equipment consists of a computer, internet connection and standard office supplies.

## **Class Recordings and Confidentiality**

All classes are recorded for later viewing of Radiant Living students and clients. Students waive any right for content of classes to remain confidential. Using discretion, good taste and kindness, Radiant Living administrators post clips of classes in newsletters and on social media for the purpose of promoting the school. This pertains mainly to content created by guest teachers. Most classes are password protected on Vimeo, but occasionally, school administrators make recordings public for the purpose of promoting the school and the guest teacher.

#### **National Certification**

The National Ayurvedic Medical Association (NAMA), as of September 2017, has a board exam for AHC certification and will have a board exam for AP certification as of January 2018. Students will become board certified at the national level through NAMA upon successful completion of these tests. Radiant Living abides by NAMA standards and updates our programs regularly to assure compliance. Students are strongly encouraged to maintain membership and actively participate in NAMA.
