On April 3, 2012, the Wisconsin Board of Nursing ("Board") issued an Order Granting Reinstatement and Limited License ("Order"), which reinstated Respondent's professional nursing license with an indefinite suspension following previous revocation. Respondent has been granted a stay of suspension and her license is currently limited with certain terms and conditions.

On November 14, 2019, the Board considered Respondent's request for modification of the length of the Order and a reduction in screens. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Respondent's request for a reduction in screens is hereby GRANTED. Respondent's frequency is reduced to not less than 28 per year and an annual hair test.


2. Respondent's request for a modification of the length of the Order is hereby DENIED for insufficient time under the Board Order (4/3/2012) to demonstrate adequate compliance.

3. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
