On May 6, 2010, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") suspending Respondent's professional nursing license for an indefinite period. Respondent has been granted a stay of suspension and her license is currently limited with certain terms and conditions.

On December 12, 2019, the Board considered Respondent's request for full licensure or a reduction in the frequency of drug and alcohol screens. Based upon the information of record, the Board finds and makes the following:

## **ORDER**

- 1. Respondent's request for full, unrestricted licensure is hereby DENIED for failure to demonstrate continuous and successful compliance under the terms of the Order.
- 2. Respondent's request for a reduction in the frequency of screens is hereby GRANTED to not less than 28 screens per year and one hair test. Additionally, the Board removes the requirement for direct supervision.
- 3. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
  - 4. This order is effective the date of its signing.
