On August 16, 2012, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("August 2012 Order") limiting Respondent's professional nursing license with certain terms and conditions.

On October 11, 2018, the Board reviewed the information of record and found Respondent to be in violation of the August 2012 Order. As a result, the Board issued an Order Suspending License and Imposing Additional Limitations on October 26, 2018 ("October 2018 Order"), which required at least thirty (30) days of compliance before Respondent may request a stay of suspension. Respondent has been granted a stay of suspension and her license is currently limited with certain terms and conditions.


Information has been received that demonstrates Respondent has failed to comply with all requirements for participation in the drug and alcohol monitoring program and therefore is in violation of the terms of the October 26, 2018 Order. As a result, the following is entered:

ORDER

1. The stay of suspension is removed and Respondent's professional nursing license (#161594-30) is hereby SUSPENDED until further notice.
2. This order is effective immediately.
