## TO: SUSAN THIEL RN MENOMONEE FALLS WI 53051

On June 13, 2013, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") suspending Respondent's professional nursing license for an indefinite period. Respondent has been granted a stay of suspension and her license is currently limited with certain terms and conditions.

On November 14, 2019, the Board considered Respondent's request for termination of direct supervision, termination of home health, a reduction in screens and a reduction in AA/NA meetings. Based upon the information of record, the Board finds and makes the following:

### **ORDER**

1. Respondent's request for termination of direct supervision is hereby GRANTED.

2. Respondent's request for a reduction in screens is hereby GRANTED. Respondent's frequency is reduced to not less than 36 per year and an annual hair test.

3. Respondent's request for termination of home health and a reduction in AA/NA meetings is hereby DENIED for insufficient time under the Board Order (6/13/2013) to demonstrate adequate compliance.

4. All other terms and conditions of the Order not otherwise modified remain in full force and effect.

5. This order is effective the date of its signing.
