On December 11, 2013, the Wisconsin Medical Examining Board ("Board") issued a Final Decision and Order ("December 11, 2013 Order"), granting Applicant a limited license to practice medicine and surgery with certain terms and conditions. On October 23, 2018, the Board issued an Order Affirming Denial of Full Licensure and Imposing Additional Limitations ("October 23, 2018 Order"), further limiting Applicant's license with certain terms and conditions. Pursuant to the October 23, 2018 Order, Applicant's license may be suspended, without further notice or hearing, for substantial or repeated violation of any provision.

Information has been received that demonstrates Applicant has not submitted an attestation that he has ceased the independent practice of medicine and surgery and is therefore in violation of the terms of the October 23, 2018 Order. As a result, the following is entered:

#### ORDER

- Applicant's license to practice medicine and surgery (#61782-20) is hereby SUSPENDED until further notice.
