On May 8, 2014, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("May 2014 Order") suspending Respondent's professional nursing license for an indefinite period. Respondent was ordered to pay costs of the proceeding, and she may petition the Board for a stay of suspension upon completing a fitness for duty assessment and an alcohol and other drug abuse (AODA) assessment.

On December 13, 2018, the Board reviewed and accepted Respondent's fitness for duty and AODA assessments reports. As a result, the Board issued an Order Granting Stay and Imposing Limitations on January 15, 2019 ("January 2019 Order").

Information has been received that demonstrates Respondent is in violation of the terms of the May 2014 Order by failing to pay the costs of the proceeding, and the January 2019 Order by failing to comply with the requirements for participation in the drug and alcohol monitoring program. As a result, the following is entered:

## ORDER

The stay of suspension is removed and Respondent's right to renew her professional 1. nursing license (#187352-30) is hereby SUSPENDED until further notice.

Respondent may petition for reinstatement of the stay and the right to renew her 2. professional nursing license upon providing proof, determined by the Board or its designee to be sufficient, that Respondent is in compliance with the May 2014 Order and the January 2019 Order.

This order is effective immediately. 3.
