On September 8, 2014, the Wisconsin Department of Safety and Professional Services ("Department") issued a Final Decision and Order ("Order") suspending Respondent's clinical supervisor-in-training certificate for an indefinite period. Respondent has been granted a stay of suspension and her certificate is currently limited with certain terms and conditions.

On October 23, 2019, the Department Designee considered Respondent's request for termination of the treatment limitations and practice limitation relating to the treatment of male clients. Based upon the information of record, the Department Designee finds and makes the following:

ORDER

- Respondent's request for a termination of the treatment requirements, outlined in provisions C.1.-C.6. of the Order, is GRANTED upon discharge by her current treatment provider.
- Respondent's request for termination of the practice limitation relating to the 2. treatment of male clients, outlined in provision C.8. of the Order, is GRANTED.
- All other terms and conditions of the Order not otherwise modified remain in full 3. force and effect.
