On January 8, 2015, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") limiting Respondent's professional nursing license with certain terms and conditions, including participation in a drug monitoring program.

Respondent recently petitioned for a reduction in frequency of drug screens. Based upon the information of record and review by the Board designee, the following is entered:

ORDER

1. Respondent's request for a reduction in drug screens is hereby GRANTED. Respondent's frequency is reduced to not less than 36 screens per year.
2. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
3. This order is effective the date of its signing.
