On March 12, 2015, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") suspending Respondent's professional nursing license for an indefinite period. Respondent has been granted a stay of suspension and his license is currently limited with certain terms and conditions.

On March 14, 2019, the Board considered Respondent's request for termination of direct supervision, termination of practice limitations, reduction in drug screens and termination of abstaining from personal use of alcohol. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Respondent's request for termination of direct supervision, removal of setting restrictions, and a reduction in screens to not less than 28 per year plus one annual hair test. is hereby GRANTED.

2. Respondent's request for termination of abstaining from personal use of alcohol is hereby DENIED due to insufficient time under the Board Order (3/12/2015) to demonstrate adequate compliance.

3. All other terms and conditions of the Order not otherwise modified remain in full force and effect.

4. This order is effective the date of its signing.
