On July 20, 2015, the Wisconsin Physical Therapy Examining Board ("Board") issued a Final Decision and Order ("Order") suspending Respondent's five (5) year right to renew for an indefinite period. Respondent was granted a stay of the suspension and his license is currently limited with certain terms and conditions, including participation in a drug and alcohol monitoring program.

The Board designee has considered Respondent's request for a reduction in the frequency of drug and alcohol screens. Based upon the information of record, the following is entered:

ORDER

1. Respondent's request for a reduction in drug and alcohol screens is hereby GRANTED. Respondent's frequency is reduced to not less than 36 urine screens per year.
2. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
3. This order is effective the date of its signing.
