On October 21, 2015, the Wisconsin Medical Examining Board ("Board") issued a Final Decision and Order ("Order") suspending Respondent's license to practice medicine and surgery for an indefinite period. Respondent has been granted a stay of suspension and his license is currently limited with certain terms and conditions.

On May 15, 2019, the Board considered Respondent's request for reinstatement of full licensure or termination of treatment, permission to reapply for a DEA COR, and permission to prescribe, dispense, administer or order controlled substances. Based upon the information of record, the Board finds and makes the following:

ORDER

- Respondent's request for reinstatement of full licensure is hereby DENIED for lack of full compliance with the Order.
- Respondent's request for termination of treatment, permission to reapply for a DEA COR, and permission to prescribe, dispense, administer or order controlled substances is hereby GRANTED.
- All other terms and conditions of the Order not otherwise modified remain in full force and effect.
