On November 9, 2015, the Wisconsin Real Estate Examining Board ("Board") issued an Order Granting Limited License ("Order"), which granted Applicant a limited real estate salesperson license with certain terms and conditions. On September 25, 2018 the Board issued an Order Suspending License, suspending Applicant's real estate salesperson license (#81149-94) for an indefinite period for violation of the terms of the Order.

On October 24, 2019, the Board considered Applicant's request for termination of the suspension. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Applicant's request for termination of the suspension is hereby DENIED for failure to comply with original 11/09/2015 Order, failure to report conviction, new OWI conviction, and open disciplinary case.
