On July 14, 2016, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") suspending Respondent's professional nursing license for an indefinite period. Respondent has been granted a stay of suspension and his license is currently limited with certain terms and conditions.

On October 17, 2019, the Board Liaison considered Respondent's request for a reduction in the frequency of drug and alcohol screens. Based upon the information of record, the Board Liaison finds and makes the following:

### ORDER

Respondent's request for a reduction in drug and alcohol screens is hereby 1. GRANTED. Respondent's frequency is reduced to not less than 36 per year.

2. All other terms and conditions of the Order not otherwise modified remain in full force and effect.

3. This order is effective the date of its signing.
