On April 6, 2017, the Wisconsin Pharmacy Examining Board ("Board") issued a Final Decision and Order ("Order") suspending Respondent's pharmacist license for seven (7) days from the date of the Order. Respondent's license was also limited with certain terms and conditions.

On May 22, 2019, the Board considered Respondent's request for the return of full, unrestricted licensure. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Respondent's request for the return of his pharmacist license (#17211-40) to full, unrestricted status is hereby GRANTED.
2. All limitations and encumbrances upon Respondent's credential are hereby removed.
3. This order is effective the date of its signing.
