On January 9, 2018, the Wisconsin Pharmacy Examining Board issued a Final Decision and Order ("Order") suspending Respondent's pharmacist license for two months. Respondent's license was also limited with certain terms and conditions. Pursuant to the Order, Respondent's license may be suspended, without hearing, for substantial or repeated violation of any provision.

Information has been received that demonstrates Respondent is in violation of provisions 2.g. and 2.h. of the Order, by submitting a fraudulent prescription to the Department Monitor in response to a positive urine screen. As a result, the following is entered:

1. Respondent's pharmacist license (#14257-40) is hereby SUSPENDED until further notice.
