On January 30, 2018, the Wisconsin Social Worker Section of the Marriage and Family Therapy, Professional Counseling and Social Work Examining Board issued a Final Decision and Order ("Order") requiring Respondent to complete six (6) hours of education on the topic of "confidentiality law applicable to the social work field" within ninety (90) days and pay \$842.00 in costs of the proceeding within 120 days. On September 18, 2018, Respondent's advanced practice social worker certificate was suspended for failure to complete the education and pay the costs of the proceeding as ordered.

Based upon the information of record, which includes proof that Respondent has now completed the education and submitted the payment for costs in full, the following is entered:

- The suspension is terminated and Respondent's expired advanced practice social 1. worker certificate (#130088-121) is hereby returned to full, unrestricted status. Respondent will need to renew this credential before returning to practice.
