On February 2, 2018, the Wisconsin Board of Nursing ("Board") issued an Order Granting Limited License ("Order"), which granted Applicant a limited professional nursing license with certain terms and conditions.

On February 14, 2019, the Board considered Respondent's request for termination of drug and alcohol treatment, reduction in screens, termination of direct supervision, termination of setting limitations, ability to pass controlled substances and termination of AA/NA log. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Applicant's request for termination of drug and alcohol treatment is hereby GRANTED.
2. Applicant's request for reduction in screens, termination of direct supervision, termination of setting limitations, ability to pass controlled substances and termination of AA/NA log is hereby DENIED due to insufficient time under the Board Order (February 2, 2018) to demonstrate adequate compliance.
3. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
4. This order is effective the date of its signing.
