On May 30, 2018, the Wisconsin Real Estate Examining Board ("Board") granted Applicant a limited real estate salesperson license in the state of Wisconsin. Pursuant to the Order Granting Limited License ("Order") issued on the same date, Applicant may petition the Board for removal of the limitations upon the completion of at least one year of practice in compliance with all terms and conditions of the Order.

On October 24, 2019, the Board considered Applicant's request for a full, unrestricted real estate salesperson license. Based upon the information of record, the Board finds and makes the following:

## **ORDER**

- 1. Applicant's request for a full, unrestricted real estate salesperson license is hereby DENIED for a conviction substantially related to the practice of Real Estate, and failure to report police contact and a conviction to the Board in a timely manner. Applicant may petition the Board again after May 30, 2020.
