The Board designee has considered Applicant's request for a reduction in the frequency of drug screens. Based upon the information of record, the following is entered:

- 1. Applicant's request for a reduction in drug screens is hereby GRANTED. Applicant's frequency is reduced to not less than 14 urine screens per year and one annual hair test.
