On August 3, 2018, the Wisconsin Board of Nursing ("Board") issued an Order Granting Limited License ("Order"), which granted Applicant a limited professional nursing license with certain terms and conditions, including participation in a drug and alcohol monitoring program.

The Board designee has considered Applicant's request for a reduction in the frequency of drug and alcohol screens. Based upon the information of record, the following is entered:

ORDER

1. Applicant's request for a reduction in drug and alcohol screens is hereby GRANTED. Applicant's frequency is reduced to not less than 36 urine screens per year.
2. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
3. This order is effective the date of its signing.
