On August 10, 2018, the Wisconsin Board of Nursing issued an Order Granting Limited License ("Order"), which granted Applicant a limited professional nursing license with certain terms and conditions. Pursuant to the Order, Applicant's license may be suspended, without further notice or hearing, for substantial or repeated violation of any provision.

Information has been received that demonstrates Applicant has ceased participation in an approved drug monitoring program and is therefore in violation of the terms of the Order. As a result, the following is entered:
