On September 26, 2018, the Architect Section of the Wisconsin Examining Board of Architects, Landscape Architects, Professional Engineers, Designers and Professional Land Surveyors ("Section") issued a Final Decision and Order ("Order") limiting Respondent's architect registration. Respondent was required to complete 13 hours of education, 12 of which must be on HSW topics pursuant to terms of the Order.


Respondent has submitted proof that he successfully completed the required education and as a result the following is entered:
