On November 8, 2018, the Wisconsin Board of Nursing issued a Final Decision and Order ("Order") requiring Respondent to pay \$640.00 in costs of the proceeding, within 120 days from the date of the Order. Respondent was also required to complete three (3) hours of education on the topic of ethics and professionalism and five (5) hours of education on the topic of documentation and record keeping, within 90 days from the date of the Order. On April 10, 2019, Respondent's professional nursing license was suspended for failure to pay the costs of the proceeding and to complete the education as ordered.

Based upon the information of record, which includes proof that Respondent has submitted payment for the costs of the proceeding in full and completed the required education, the following is entered:

ORDER

1. The suspension of Respondent's professional nursing license (#197138-30) is terminated.
2. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
3. This order is effective the date of its signing.
