On November 14, 2018, the Wisconsin Medical Examining Board ("Board") issued a Final Decision and Order ("Order") suspending Respondent's license to practice medicine and surgery for an indefinite period. Respondent may petition for a stay of suspension upon providing proof that Respondent is in compliance with the provisions of Sections C and D of the Order, and that Respondent's Treater is of the opinion that Respondent is able to safely practice under the restrictions of the Order.
