
On November 27, 2018, the Wisconsin Funeral Directors Examining Board issued a Final Decision and Order ("Order") requiring Respondent Frazier to complete six (6) hours of education on "professional conduct and business ethics" within 60 days. On February 11, 2019, Respondent Frazier's funeral director license was suspended for failure to complete the education as ordered.

Based upon the information of record, which includes proof that Respondent Frazier has now completed the education, the following is entered:

ORDER

1. The suspension is terminated and Respondent Frazier's funeral director license (#4898-77) is hereby returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent Frazier's credential are removed.
3. This order is effective the date of its signing.
