On January 10, 2019, the Wisconsin Board of Nursing issued a Final Decision and Order ("Order") limiting Respondent's practical nursing license with certain terms and conditions. Information has been received that demonstrates Respondent has failed to enroll and participate in an approved drug monitoring program and is therefore is in violation of the terms of the Order. As a result, the following is entered:
