On February 1, 2019, the Wisconsin Real Estate Examining Board issued an Order Granting Limited License ("Order"), which granted Applicant a limited real estate salesperson license with certain terms and conditions. Pursuant to the Order, Applicant's license may be suspended, without further notice or hearing, for substantial or repeated violation of any provision.

The information of record demonstrates that Applicant has failed to attend Alcoholics Anonymous and/or Narcotics Anonymous meetings (AA/NA) at least twice per week and report verification of his attendance quarterly to the Department Monitor. Applicant also has failed to submit, or ensure the submission of, quarterly treatment reports. Applicant is therefore in violation of the terms of the Order and as a result, the following is entered:

1. Applicant's real estate salesperson license (#88059-94) is hereby SUSPENDED until further notice.
2. This order is effective the date of its signing.
