
On February 19, 2019, the Wisconsin Funeral Directors Examining Board ("Board") issued a Final Decision and Order ("Order") limiting Respondent's funeral director license. Respondent was required to complete eight hours of education in accordance with Wis. Admin. Code § FD 4.03 and include the following subject areas: one hour as defined in Wis. Admin. Code § FD 4.04(1)(a)1, two hours as defined in Wis. Admin. Code § FD 4.04(1)(a)2, one hour as defined in Wis. Admin. Code § FD 4.04(1)(a)3, and one hour as defined in Wis. Admin. Code § FD 4.04(1)(a)4, pursuant to the terms of the Order.

Respondent has submitted proof that he successfully completed the required education and as a result the following is entered:

ORDER

1. Respondent's funeral director license (#5876-77) is returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent's credential are removed.
3. This order is effective the date of its signing.
