The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Wisconsin Board of Nursing (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law and Order.

FINDINGS OF FACT

1. Licensee Lindsey A. Peterson, R.N., (D.O.B. May 17, 1984) is licensed in the state of Wisconsin as a registered nurse, having license number 151519-30, first issued on July 22, 2005 and current through February 28, 2020. Licensee's most recent address on file with the Wisconsin Department of Safety and Professional Services (Department) is 6310 Quentin Street, Weston, Wisconsin 54476.

2. At all times relevant to this proceeding, Licensee was employed as a registered nurse at a hospital (Hospital), located in Madison, Wisconsin.

3. The Hospital utilizes an automated dispensing cabinet (Cabinet) to dispense medications. This includes medications in the form of Patient Controlled Analgesia (PCA),

which is administered with a pump. A key is required to administer a PCA to a patient. The Cabinet holds one key for this purpose. The date and time are electronically recorded when medications or the key are dispensed.

4. In early January 2017, the Hospital reviewed the documented time entries for administration of fentanyl PCAs for February 2016, through January 2017. The Hospital discovered that Licensee was administering significantly more fentanyl PCAs than her peers in December 2016.

5. In December 2016, the Hospital discovered the following discrepancies concerning Licensee's administration of fentanyl PCAs:

- a. Licensee frequently dispensed a fentanyl PCA from the Cabinet without the key while the key was in the Cabinet.
- b. On multiple occasions, Licensee's documented time entry for administration of a fentanyl PCA to a patient coincided with a time when the key was in the Cabinet.
- c. On multiple occasions, Licensee documented administering a fentanyl PCA over an hour after she dispensed the drug from the Cabinet.
- d. On one occasion, Licensee dispensed a fentanyl PCA from the Cabinet and cancelled it over two (2) hours later. There was no documentation regarding waste of this medication.

6. Between December 15, 2016, and January 2, 2017, the Hospital recorded video footage of the Cabinet. Licensee was captured on video dispensing a fentanyl PCA from the Cabinet, placing it in her pocket, and walking down the hallway away from the unit. Licensee later documented administering the fentanyl PCA.

7. On December 15, 2016, a doctor ordered morphine injections for breakthrough pain if oral pain medication was not sufficient. Licensee administered the maximum dosage of morphine injections to a patient prior to attempting oral medication.

8. On January 3, 2017, Licensee was placed on administrative leave, pending the outcome of a Fitness for Duty Exam and the investigation into Licensee's administration practice, performance, and behavior.

9. On January 19, 2017, and February 2, 2017, the Hospital held investigatory meetings with Licensee regarding the various discrepancies with her administration of medication. Licensee admitted to the Hospital that she had gone into the bathroom with a PCA in her pocket, but she denied taking controlled substances from the Hospital.

10. On February 7, 2017, the Hospital terminated Licensee based upon suspicion of diversion, recent behavior, as well as failure to notify regarding prescriptions and use of narcotics.

11. In resolution of this matter, Licensee consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

1. The Wisconsin Board of Nursing is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).

ORDER

1. The attached Stipulation is accepted.

2. Within six (6) months of the date of this Order, Lindsey A. Peterson, R.N., shall at her own expense, take and successfully complete four (4) hours of education on the topic of medication errors and five (5) hours of education on documentation as follows:

- a. Each course attended in satisfaction of this Order must be pre-approved by the Board or its designee. Licensee shall be responsible for locating course(s) satisfactory to the Board and for obtaining the required approval of the courses from the Board or its designee. Licensee must take and pass any exam offered for the course(s).
- b. Licensee shall submit proof of successful completion of the education in the form of verification from the institution providing the education to the Department Monitor at the address stated below. None of the education completed pursuant to this requirement may be used to satisfy any education requirements that have been or may be instituted by the Board or Department.

3. Request for approval of courses and proof of successful course completion shall be sent by Licensee to the Department Monitor at the address below:

STIPULATION

Licensee Lindsey A. Peterson, R.N., and the Division of Legal Services and Compliance, Department of Safety and Professional Services stipulate as follows:

1. This Stipulation is entered into as a result of a pending investigation by the Division of Legal Services and Compliance. Licensee consents to the resolution of this investigation by Stipulation.

2. Licensee understands that by signing this Stipulation, Licensee voluntarily and knowingly waives the following rights:

- the right to a hearing on the allegations against Licensee, at which time the State has the burden of proving those allegations by a preponderance of the evidence;
- the right to confront and cross-examine the witnesses against Licensee;
- the right to call witnesses on Licensee's behalf and to compel their attendance by subpoena;
- the right to testify on Licensee's own behalf;
- the right to file objections to any proposed decision and to present briefs or oral arguments to the officials who are to render the final decision;
- the right to petition for rehearing; and
- all other applicable rights afforded to Licensee under the United States Constitution, the Wisconsin Constitution, the Wisconsin Statutes, the Wisconsin Administrative Code, and other provisions of state or federal law.

3. Licensee is aware of Licensee's right to seek legal representation and has been provided an opportunity to obtain legal counsel before signing this Stipulation.

4. Licensee agrees to the adoption of the attached Final Decision and Order by the Wisconsin Board of Nursing (Board). The parties to the Stipulation consent to the entry of the attached Final Decision and Order without further notice, pleading, appearance or consent of the parties. Licensee waives all rights to any appeal of the Board's order, if adopted in the form as attached.


5. If the terms of this Stipulation are not acceptable to the Board, the parties shall not be bound by the contents of this Stipulation, and the matter shall then be returned to the Division

of Legal Services and Compliance for further proceedings. In the event that the Stipulation is not accepted by the Board, the parties agree not to contend that the Board has been prejudiced or biased in any manner by the consideration of this attempted resolution.

6. The parties to this Stipulation agree that the attorney or other agent for the Division of Legal Services and Compliance and any member of the Board ever assigned as an advisor in this investigation may appear before the Board in open or closed session, without the presence of Licensee, for purposes of speaking in support of this agreement and answering questions that any member of the Board may have in connection with deliberations on the Stipulation. Additionally, any such advisor may vote on whether the Board should accept this Stipulation and issue the attached Final Decision and Order.


7. Licensee is informed that should the Board adopt this Stipulation, the Board's Final Decision and Order is a public record and will be published in accordance with standard Department procedure.

8. The Division of Legal Services and Compliance joins Licensee in recommending the Board adopt this Stipulation and issue the attached Final Decision and Order.
