
On March 21, 2019, the Wisconsin Real Estate Examining Board ("Board") issued a Final Decision and Order ("Order") limiting Respondent Gerke-Edwards' real estate broker license. Respondent Gerke-Edwards was required to complete nine hours of education on the topics of Approved Forms, Business Ethics and Consumer Protection, pursuant to the terms of the Order.

Respondent Gerke-Edwards has submitted proof that she successfully completed the required education and as a result the following is entered:

1. Respondent Gerke-Edwards' real estate broker license (#38366-90) is returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent's credential are removed.
