The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Medical Examining Board (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law and Order.

#### FINDINGS OF FACT

- 1. Respondent Thomas E. Goodrich M.D. (DOB August 12, 1959), is licensed in the state of Wisconsin to practice medicine and surgery, having license number 28720-20, first issued on July 1, 1987, with registration current through October 31, 2019. Respondent's most recent address on file with the Wisconsin Department of Safety and Professional Services (Department) is 6015 Durand Avenue, Suite 500, Racine, Wisconsin 53406.
- 2. Respondent practiced family medicine before retiring and closing his solo practice office in February 2019.

- 3. On October 31, 2015, the Division of Legal Services and Compliance (Division) received a National Practitioner DataBank report stating that on September 25, 2015, a hospital where Respondent held clinical privileges had revoked those privileges for failing to comply with a corrective action plan.
- 4. The Division obtained records from the hospital including the corrective action plan and related findings with respect to Respondent (Hospital File).
- 5. The Hospital File reflected allegations that Respondent engaged in disruptive behavior, had inadequate and/or untimely medical record-keeping, and raised patient care concerns.
- 6. The Hospital File reflected that Respondent was asked to comply with a corrective action plan, but that he failed to do so and that his clinical privileges were revoked as a result.
- 7. Respondent states that around the time of the issues alleged in the Hospital File, he was unexpectedly required to significantly increase his patient load due to physician turnover at his small family practice group. He states the additional work and related stress caused him health problems and left him unable to keep up with charting at the hospital.
- 8. Respondent acknowledges he was unable to comply with the record-keeping element of the corrective action plan, but denies the other issues reflected in the Hospital File.
- 9. Between October 19, 2015 and May 23, 2016, the Division sent Respondent numerous requests seeking a written reply addressing the concerns alleged in the Hospital File. Requests were sent by mail and email to Respondent's addresses of record with the Department, but Respondent failed to respond to any of them.
  - 10. Respondent consents to entry of the following Conclusions of Law and Order.

#### CONCLUSIONS OF LAW

- 1. The Wisconsin Medical Examining Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 448.02(3) and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).
- 2. Respondent engaged in unprofessional conduct as defined by Wis. Admin. Code § Med 10.03(3)(g) by failing to cooperate in a timely manner with the board's investigation of a complaint filed against a license holder.
- 3. As a result of the above conduct, Thomas E. Goodrich, M.D., is subject to discipline pursuant to Wis. Stat. § 448.02(3).

#### ORDER

1. The attached Stipulation is accepted.

- 2. Respondent Thomas E. Goodrich, M.D., is REPRIMANDED.
- 3. Within 90 days from the date of this Order, Thomas E. Goodrich, M.D., shall pay COSTS of this matter in the amount of \$1,325.00.
- 4. Payment of costs shall be made payable to the Wisconsin Department of Safety and Professional Services and sent to the Department Monitor at the address below:

- 5. In the event Respondent violates any term of this Order, Respondent's license (no. 28720-20), or Respondent's right to renew his license, may, in the discretion of the Board or its designee, be SUSPENDED, without further notice or hearing, until Respondent has complied with the terms of the Order. The Board may, in addition and/or in the alternative refer any violation of this Order to the Division of Legal Services and Compliance for further investigation and action.
  - 6. This Order is effective on the date of its signing.

**STIPULATION**

Respondent Thomas E. Goodrich, M.D., and the Division of Legal Services and Compliance, Department of Safety and Professional Services stipulate as follows:

- 1. This Stipulation is entered into as a result of a pending investigation by the Division of Legal Services and Compliance. Respondent consents to the resolution of this investigation by Stipulation.
- 2. Respondent understands that by signing this Stipulation, Respondent voluntarily and knowingly waives the following rights:
  - the right to a hearing on the allegations against Respondent, at which time the State has the burden of proving those allegations by a preponderance of the evidence;
  - the right to confront and cross-examine the witnesses against Respondent;
  - the right to call witnesses on Respondent's behalf and to compel their attendance by subpoena;
  - the right to testify on Respondent's own behalf;
  - the right to file objections to any proposed decision and to present briefs or oral arguments to the officials who are to render the final decision;
  - the right to petition for rehearing; and
  - all other applicable rights afforded to Respondent under the United States Constitution, the Wisconsin Constitution, the Wisconsin Statutes, the Wisconsin Administrative Code, and other provisions of state or federal law.
- 3. Respondent is aware of Respondent's right to seek legal representation and has been provided an opportunity to obtain legal counsel before signing this Stipulation.
- 4. Respondent agrees to the adoption of the attached Final Decision and Order by the Wisconsin Medical Examining Board (Board). The parties to the Stipulation consent to the entry of the attached Final Decision and Order without further notice, pleading, appearance or consent of the parties. Respondent waives all rights to any appeal of the Board's order, if adopted in the form as attached.
- 5. If the terms of this Stipulation are not acceptable to the Board, the parties shall not be bound by the contents of this Stipulation, and the matter shall then be returned to the Division

of Legal Services and Compliance for further proceedings. In the event that the Stipulation is not accepted by the Board, the parties agree not to contend that the Board has been prejudiced or biased in any manner by the consideration of this attempted resolution.

- 6. The parties to this Stipulation agree that the attorney or other agent for the Division of Legal Services and Compliance and any member of the Board ever assigned as an advisor in this investigation may appear before the Board in open or closed session, without the presence of Respondent or Respondent's attorney, for purposes of speaking in support of this agreement and answering questions that any member of the Board may have in connection with deliberations on the Stipulation. Additionally, any such advisor may vote on whether the Board should accept this Stipulation and issue the attached Final Decision and Order.
- 7. Respondent is informed that should the Board adopt this Stipulation, the Board's Final Decision and Order is a public record and will be published in accordance with standard Department procedure.
- 8. The Division of Legal Services and Compliance joins Respondent in recommending the Board adopt this Stipulation and issue the attached Final Decision and Order.
