On May 9, 2019, the Wisconsin Board of Nursing issued a Final Decision and Order ("Order") requiring Respondent to pay \$1,067.00 in costs of the proceeding within 120 days and complete four (4) hours of education on medication errors and five (5) hours on documentation within 90 days from the date of the Order.

The information of record demonstrates that Respondent has failed to pay the costs of the proceeding and to complete the education requirements. Therefore, the following is entered:

### <u>ORDER</u>

1. Respondent's professional nursing license (#157163-30) is hereby SUSPENDED.

2. The suspension shall remain in effect until Respondent has paid the costs of the proceeding in full and has demonstrated successful completion of the education requirements of the Order.
