On May 15, 2019, the Wisconsin Medical Examining Board ("Board") issued a Final Decision and Order ("Order") limiting Respondent's license to practice medicine and surgery. Respondent was required to complete six (6) hours of education on the topic of prescribing for psychiatrists pursuant to the terms of the Order.
