On May 22, 2019, the Wisconsin Pharmacy Examining Board ("Board") issued a Final Decision and Order ("Order") suspending Respondent's pharmacist license a period of three (3) years. Respondent was granted an immediate stay of the suspension, and her license is currently limited with certain terms and conditions.

According to the Order, the stay of suspension shall be lifted for fourteen (14) consecutive days, as proposed by the Respondent, within the first six (6) months. The stay shall be reinstated after fourteen (14) days, at which time Respondent's license will be limited with certain terms and conditions.

Respondent has notified the Department Monitor that she wishes to commence the suspension pursuant to the terms of the Order, and as a result the following is entered:

ORDER

1. The stay of suspension is removed and Respondent's pharmacist license (#16630-40) is hereby SUSPENDED for fourteen (14) consecutive days, effective September 5, 2019.
2. The stay of suspension shall be reinstated, allowing the Respondent to return to practice, on September 20, 2019.
3. This order is effective immediately.
