
On June 13, 2019, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") limiting Respondent's professional nursing license. Respondent was required to complete 4 hours of education in ethics of nursing practice and 5 hours in professional accountability and legal liability for nurses pursuant to the terms of the Order.

Respondent has submitted proof that she successfully completed the required education and as a result the following is entered:

ORDER

1. Respondent's professional nursing license (#190548-30) is returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent's credential are removed.
3. This order is effective the date of its signing.
