You are hereby notified that you are subject to a forfeiture of **\$300.00** in accordance with Wis. Stat. § 101.88(3) and Wis. Admin. Code § SPS 305.12 for your engagement in electrical work as a registered electrician without the direct supervision of a master electrician in violation of Wis. Stat. § 101.862 and Wis. Admin. Code § SPS 305.40. This forfeiture must be paid within 30 days of the date of mailing of this Notice, or a 12% interest penalty will be assessed and/or enforcement action may be taken against you.

The forfeiture of **\$300.00** shall be made out to the "Department of Safety and Professional Services." Include in the memo line "18 COM 231" and send to the following address:

You have the right to request a review of the assessment of forfeiture by sending a request addressed to General Counsel of the Department of Safety and Professional Services at P.O. Box 8368, Madison, WI 53708-8368 which must be received by the Department no later than 30 days from the date of mailing of this Notice. Any review of the assessment of forfeiture will be held in accordance with the requirements set forth in Wis. Stat. § 101.02(6). Such request for review shall be by verified petition filed with the Department, setting out specifically and in full detail every reason why this order is unreasonable, and every issue to be considered by the Department on the hearing. The petitioner shall be deemed to have finally waived all objections

to any irregularities and illegalities in this order other than those set forth in the petition. Wis. Stat. § 101.02(6)(f).


Upon receipt of such petition, if the issues raised in such petition have been adequately considered, the Department shall determine the same by confirming without hearing its previous determination. If such hearing is necessary to determine the issues raised, the Department shall order a hearing and consider and determine the matter in question. Notice of the time and place of such hearing shall be given to the petitioner and to such other persons as the Department may find directly interested in such decision.

You are receiving this forfeiture because you engaged in electrical work as a registered electrician without a master electrician overseeing the work performed at 7585 Eliason Road Sturgeon Bay, WI, 54235 in violation of Wisconsin statutes and code<sup>1</sup>. An investigation by the Department found that you cut the electrical meter seal and removed the meter and did an electrical service upgrade and that you performed this work on your own behalf. The Department attempted to reach you via letter on May 2, 2019, and never received a response.

Wisconsin code states that "a person who is enrolled as a registered electrician shall perform electrical wiring activities under the direct supervision of a person who holds a license either as a licensed master electrician or a licensed journeyman electrician, or holds a registration as a registered master electrician." Wis. Admin. Code § SPS 305.40(4)(d).

For these reasons the forfeiture of \$300.00 is assessed in accordance with Wis. Stat. § 101.88(3)<sup>2</sup>.

<sup>1</sup> Wis. Stat. § 101.862(3): No person who is not a master electrician may install, repair, or maintain electrical wiring unless a master electrician is at all times responsible for the person's work.

<sup>2</sup> Wis. Stat. § 101.88(3): Any person who violates this subchapter or any rule promulgated under this subchapter shall forfeit to the state not less than \$25 nor more than \$500 for each violation. Each day of violation constitutes a separate offense.
