The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Wisconsin Board of Nursing (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law, and Order.

FINDINGS OF FACT

- 1. Respondent Martini J. Washington, R.N., (DOB May 9, 1960) is licensed in the state of Wisconsin as a registered nurse, having license number 94516-30, first issued on August 22, 1986, and current through February 28, 2020. Respondent's most recent address on file with the Wisconsin Department of Safety and Professional Services (Department) is 3726 North 23rd Street, Milwaukee, Wisconsin 53206.
- 2. At all times relevant to this proceeding, Respondent was employed as a nurse at a facility (Facility), located in Milwaukee, Wisconsin.

- 3. On July 26, 2017, the Department received an allegation of caregiver misconduct and a Misconduct Incident Report from the Facility.
- 4. On July 15, 2017, Respondent picked up an extra shift as on the brain injury unit and as building supervisor.
- 5. On July 15, 2017, at approximately 4:44 p.m., Respondent was called to Patient A's unit after Patient A fell. Respondent was told that Patient A's fall was unwitnessed. Respondent assessed Patient A, gave him a tablet of Tylenol® 650 mg, and returned to the first floor to make rounds.
- 6. On July 15, 2017, at approximately 6:00 p.m., Patient A fell again. Respondent assessed Patient A and encouraged the patient to remain on the floor until an x-ray was done. Patient A was provided a pillow and left in a comfortable position.
- 7. Patient A appeared to be in pain and Respondent did not want to move the patient and risk further aggravation of any potential injuries. Respondent instructed another nurse to order an x-ray stat and directed staff to conduct periodic checks on Patient A.
- 8. On July 15, 2017, at approximately 10:25 p.m., Patient A was x-rayed, and the radiology report showed a right intertrochanteric femur fracture with separation of the lesser trochanter.
- 9. On July 16, 2017, at approximately 12:10 a.m., Patient A was transported to hospital and underwent surgical repair.
- 10. The Facility's fall policy required emergency medical technicians to be notified if a resident was not medically appropriate to transfer from the floor.
- 11. In resolution of this matter, Respondent consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

- 1. The Wisconsin Board of Nursing has jurisdiction to act in this matter pursuant to Wis. Stat. § 441.07, and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).
- 2. By the conduct described in the Findings of Fact, Martini J. Washington, R.N., violated Wis. Admin. Code § N 7.03(6)(c), by departing from or failing to conform to the minimal standards of acceptable nursing practice that may create unnecessary risk or danger to a patient's life, health, or safety.
- 3. As a result of the above conduct, Martini J. Washington, R.N., is subject to discipline pursuant to Wis. Stat. § 441.07(1g)(b) and (d).

<u>ORDER</u>

- 1. The attached Stipulation is accepted.
- 2. Respondent Martini J. Washington, R.N., is REPRIMANDED.
- 3. The registered nursing license issued to Martini J. Washington, R.N., (license number 94516-30) and her privilege to practice in Wisconsin pursuant to the Enhanced Nurse Licensure Compact, are LIMITED as follows:
 - a. Within ninety (90) days of the date of this Order, Respondent shall at her own expense, successfully complete three (3) hours of education on the topic of critical thinking, and five (5) hours of education on the topic of professional accountability and legal liability, offered by a provider preapproved by the Board's monitoring liaison, including taking and passing any exam offered for the courses.
 - b. Respondent shall submit proof of successful completion of the education in the form of verification from the institution providing the education to the Department Monitor at the address stated below. None of the education completed pursuant to this requirement may be used to satisfy any continuing education requirements that have been or may be instituted by the Board or Department, and also may not be used in future attempts to upgrade a credential in Wisconsin.
 - c. This limitation shall be removed from Respondent's license after satisfying the Board or its designee that Respondent has successfully completed all of the ordered education
- 4. Pursuant to the Enhanced Nurse Licensure Compact, Respondent's nursing practice is limited to Wisconsin during the pendency of this limitation.
- 5. Within 120 days from the date of this Order, Martini J. Washington, R.N., shall pay COSTS of this matter in the amount of \$406.00.
- 6. Request for approval of courses, proof of successful course completion and payment of costs (made payable to the Wisconsin Department of Safety and Professional Services) shall be sent by Respondent to the Department Monitor at the address below:

STIPULATION

ORDER 0006267

Division of Legal Services and Compliance Case No. 17 NUR 517

Respondent Martini J. Washington, R.N., and the Division of Legal Services and Compliance, Department of Safety and Professional Services stipulate as follows:

- 1. This Stipulation is entered into as a result of a pending investigation by the Division of Legal Services and Compliance. Respondent consents to the resolution of this investigation by Stipulation.
- 2. Respondent understands that by signing this Stipulation, Respondent voluntarily and knowingly waives the following rights:
 - the right to a hearing on the allegations against Respondent, at which time the State has the burden of proving those allegations by a preponderance of the evidence;
 - the right to confront and cross-examine the witnesses against Respondent;
 - the right to call witnesses on Respondent's behalf and to compel their attendance by subpoena;
 - the right to testify on Respondent's own behalf;
 - the right to file objections to any proposed decision and to present briefs or oral arguments to the officials who are to render the final decision;
 - the right to petition for rehearing; and
 - all other applicable rights afforded to Respondent under the United States Constitution, the Wisconsin Constitution, the Wisconsin Statutes, the Wisconsin Administrative Code, and other provisions of state or federal law.
- 3. Respondent is aware of Respondent's right to seek legal representation and has been provided an opportunity to obtain legal counsel before signing this Stipulation.
- 4. Respondent agrees to the adoption of the attached Final Decision and Order by the Wisconsin Board of Nursing (Board). The parties to the Stipulation consent to the entry of the attached Final Decision and Order without further notice, pleading, appearance or consent of the parties. Respondent waives all rights to any appeal of the Board's order, if adopted in the form as attached.
- 5. If the terms of this Stipulation are not acceptable to the Board, the parties shall not be bound by the contents of this Stipulation, and the matter shall then be returned to the Division

of Legal Services and Compliance for further proceedings. In the event that the Stipulation is not accepted by the Board, the parties agree not to contend that the Board has been prejudiced or biased in any manner by the consideration of this attempted resolution.

- 6. The parties to this Stipulation agree that the attorney or other agent for the Division of Legal Services and Compliance and any member of the Board ever assigned as an advisor in this investigation may appear before the Board in open or closed session, without the presence of Respondent, for purposes of speaking in support of this agreement and answering questions that any member of the Board may have in connection with deliberations on the Stipulation. Additionally, any such advisor may vote on whether the Board should accept this Stipulation and issue the attached Final Decision and Order.
- 7. Respondent is informed that should the Board adopt this Stipulation, the Board's Final Decision and Order is a public record and will be published in accordance with standard Department procedure.
- 8. The Division of Legal Services and Compliance joins Respondent in recommending the Board adopt this Stipulation and issue the attached Final Decision and Order.
