On August 6, 2019, the Wisconsin Real Estate Appraisers Board ("Board") issued a Final Decision and Order ("Order") suspending Respondent's license for five (5) days beginning ten (10) calendar days from the date of the Order. Respondent's license was also limited, requiring him to complete forty-five (45) hours of education, pursuant to the Order, and prohibiting Respondent from accepting or performing industrial appraisals until he successfully completes the required education.

Respondent has served the required suspension and has submitted proof that he successfully completed the required education. As a result, the following is entered:

ORDER

1. Respondent's certified general appraiser license (#324-10) is returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent's credential are removed.
3. This order is effective the date of its signing.
