On August 8, 2019, the Wisconsin Accounting Examining Board ("Board") issued a Final Decision and Order ("Order") limiting Respondent's certified public accountant certificate and license. Respondent is prohibited from practicing as a sole proprietor until she obtains a firm license as required by Wis. Admin. Code § Accy 5.201, pursuant to the terms of the Order.

Respondent has submitted proof of firm licensure and as a result, the following is entered:

1. Respondent's certified public accountant certificate and license (#18578-1) is returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent's credential are removed.
