On August 22, 2019, the Wisconsin Real Estate Examining Board ("Board") issued a Final Decision and Order ("Order") limiting Respondent Lange's real estate broker license. Respondent Lange was required to complete nine (9) hours of education on the topics of approved forms, business ethics, and consumer protection pursuant to the terms of the Order.
