The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Medical Examining Board (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law and Order.

FINDINGS OF FACT

- 1. Respondent Dongmei Chen, M.D. (DOB December 27, 1969), is licensed in the state of Wisconsin to practice medicine and surgery, having license number 57213-20, first issued on May 14, 2012, with registration current through October 31, 2019. Respondent's most recent address on file with the Wisconsin Department of Safety and Professional Services (Department) is 164 N. Broadway, Green Bay, Wisconsin 54303-2728.
 - 2. Respondent is an ophthalmologist who treated Patient A, a male born in 1931.

- 3. Respondent first saw Patient A on February 24, 2015, when he presented with issues related to open-angle glaucoma, cataracts in both eyes, dry eye disease, and refractive errors including myopia, astigmatism and presbyopia. Respondent examined Patient A and determined his intra-ocular pressures, 10-12 in both eyes, were well-controlled with conservative measures which Respondent recommended he continue.
- 4. Respondent next saw Patient A on August 25, 2015, when he presented complaining of decreased vision since his last appointment. Respondent examined Patient A and recorded his intra-ocular pressure in both eyes as 15. Respondent and Patient A discussed the importance of medication compliance and the option of cataract surgery, including its risks and benefits.
- 5. Patient A consented to cataract surgery in both eyes, specifically single-focus intraoperative lenses, to be performed sequentially on different dates.
- 6. On the morning of September 15, 2015, Respondent performed phacoemulsification surgery with an intraoperative lens implant in Patient A's left eye.
- 7. On the afternoon of September 15, 2015, Respondent performed a post-operative examination of Patient A and recorded an intra-ocular pressure of 30 in his left eye. Respondent believed the heightened pressure was transient in nature and discharged Patient A with instructions to return for follow up in 2-3 weeks.
- 8. Respondent fell below minimal standard by not scheduling Patient A for more immediate post-operative follow up to determine whether the recorded intra-ocular pressure of 30 was indeed transient.
- 9. Respondent denies that she or her practice engaged in unprofessional conduct but to resolve this matter she consents to entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

- 1. The Wisconsin Medical Examining Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 448.02(3), and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).
- 2. By the conduct described in the Findings of Fact, Respondent Dongmei Chen, M.D., engaged in unprofessional conduct as defined by Wis. Admin. Code § Med 10.03(2)(b) (Oct. 2013) by departing from or failing to conform to the standard of minimally competent medical practice which creates an unacceptable risk of harm to a patient or the public whether or not the act or omission resulted in actual harm to any person.
- 3. As a result of the above conduct, Dongmei Chen, M.D., is subject to discipline pursuant to Wis. Stat. § 448.02(3).

ORDER

1. The attached Stipulation is accepted.

- 2. Respondent Dongmei Chen, M.D., is REPRIMANDED.
- 3. Within ninety (90) days from the date of this Order, Dongmei Chen, M.D., shall pay COSTS of this matter in the amount of \$520.00.
- 4. Payment of costs (made payable to the Wisconsin Department of Safety and Professional Services) shall be sent by Respondent to the Department Monitor at the address below:

- 5. In the event Respondent violates any term of this Order, Respondent's license (no. 57213-20), or Respondent's right to renew her license, may, in the discretion of the Board or its designee, be SUSPENDED, without further notice or hearing, until Respondent has complied with the terms of the Order. The Board may, in addition and/or in the alternative refer any violation of this Order to the Division of Legal Services and Compliance for further investigation and action.
 - 6. This Order is effective on the date of its signing.

Respondent Dongmei Chen, M.D., and the Division of Legal Services and Compliance, Department of Safety and Professional Services stipulate as follows:

- 1. This Stipulation is entered into as a result of a pending investigation by the Division of Legal Services and Compliance. Respondent consents to the resolution of this investigation by Stipulation.
- 2. Respondent understands that by signing this Stipulation, Respondent voluntarily and knowingly waives the following rights:
 - the right to a hearing on the allegations against Respondent, at which time the State has the burden of proving those allegations by a preponderance of the evidence;
 - the right to confront and cross-examine the witnesses against Respondent;
 - the right to call witnesses on Respondent's behalf and to compel their attendance by subpoena;
 - the right to testify on Respondent's own behalf;
 - the right to file objections to any proposed decision and to present briefs or oral arguments to the officials who are to render the final decision;
 - the right to petition for rehearing; and
 - all other applicable rights afforded to Respondent under the United States Constitution, the Wisconsin Constitution, the Wisconsin Statutes, the Wisconsin Administrative Code, and other provisions of state or federal law.
- 3. Respondent is aware of Respondent's right to seek legal representation and has been provided an opportunity to obtain legal counsel before signing this Stipulation. Respondent is represented by Attorney Christina Davis.
- 4. Respondent agrees to the adoption of the attached Final Decision and Order by the Wisconsin Medical Examining Board (Board). The parties to the Stipulation consent to the entry of the attached Final Decision and Order without further notice, pleading, appearance or consent of the parties. Respondent waives all rights to any appeal of the Board's order, if adopted in the form as attached.

- 5. If the terms of this Stipulation are not acceptable to the Board, the parties shall not be bound by the contents of this Stipulation, and the matter shall then be returned to the Division of Legal Services and Compliance for further proceedings. In the event that the Stipulation is not accepted by the Board, the parties agree not to contend that the Board has been prejudiced or biased in any manner by the consideration of this attempted resolution.
- 6. The parties to this Stipulation agree that the attorney or other agent for the Division of Legal Services and Compliance and any member of the Board ever assigned as an advisor in this investigation may appear before the Board in open or closed session, without the presence of Respondent or Respondent's attorney, for purposes of speaking in support of this agreement and answering questions that any member of the Board may have in connection with deliberations on the Stipulation. Additionally, any such advisor may vote on whether the Board should accept this Stipulation and issue the attached Final Decision and Order.
- 7. Respondent is informed that should the Board adopt this Stipulation, the Board's Final Decision and Order is a public record and will be published in accordance with standard Department procedure.
- 8. The Division of Legal Services and Compliance joins Respondent in recommending the Board adopt this Stipulation and issue the attached Final Decision and Order.
