IN THE MATTER OF DISCIPLINARY PROCEEDINGS AGAINST	: NOTICE OF FOREEITURE

You are hereby notified that you are subject to a forfeiture of **\$1,000.00** in accordance with Wis. Stat. § 145.12 and **\$2,500.00** in accordance with Wis. Admin. Code § SPS 305.125 for (1) your engagement in advertising as a licensed master plumber in violation of Wis. Stat. § 145.11 and (2) engaging in plumbing work without a license in violation of Wis. Stat. § 145.06 and Wis. Admin. Code § SPS 305.90. This forfeiture must be paid within 30 days of the date of mailing of this Notice, or a 12% interest penalty will be assessed and/or enforcement action may be taken against you.

The forfeiture of **\$3,500.00** shall be made out to the "Department of Safety and Professional Services." Include in the memo line "SAGE FORFEITURE" and send to the following address:

You have the right to request a review of the assessment of forfeiture by sending a request addressed to Division Administrator, Division of Industry Services, P.O. Box 7302, Madison, WI 53707-7302. Any review of the assessment of forfeiture will be held in accordance with the requirements set forth in Wis. Admin. Code § SPS 305.125. Such request for review shall set out

specifically and in full detail every reason why this order is unreasonable, and every issue to be considered by the Department in the review.

You are receiving these forfeitures because you engaged in advertising as a plumber without having the proper license. An investigation by the Department found that you presented yourself and advertised as a master plumber without having a master plumber license. The Department found invoices where you listed a master plumber license previously associated with you. Your email name line states "WISCONSIN MASTER PLUMBER #245779, STEVEN LEE SAGE." A search of youtube found videos where you advertise as a plumber. Numerous internet sites still list you as a plumber who provides plumbing services. The Department found that your company website, iremodellacrosse.com (currently inactive) advertised you as a plumber. The above shows you were advertising as a master plumber without possessing the proper license.

Second, you are receiving this forfeiture because you engaged in plumbing work at 1328 Jackson St. La Crosse, WI; 4665 Millatti Lane, La Crosse, WI; and N7905 County Road V, Holmen, WI without a license. The Department spoke with the property owners who confirmed that you engaged in plumbing and a record search found that you do not possess an active license.

You were previously issued a forfeiture in the amount of \$1,000 for advertising and installing plumbing without a license on November 29, 2017. It has been determined that you have continued to engage in advertising and unlicensed plumbing since that date, thus additional forfeitures are being entered against you.

For these reasons the forfeiture of \$3,500.00 is assessed in accordance with Wis. Stat. § 145.12 and Wis. Admin. Code § SPS 305.125.
