On May 6, 2010, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") suspending Respondent's professional nursing license for an indefinite period. Respondent has been granted a stay of suspension and her license is currently limited with certain terms and conditions.

On February 13, 2020, the Board considered Respondent's request for reinstatement of full licensure or a reduction in the frequency of screens, termination of AA/NA logs, and access to controlled substances. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Respondent's request for termination of AA/NA logs and access to controlled substances is hereby GRANTED.
2. Respondent's request for full licensure or a reduction in the frequency of drug and alcohol screens is hereby DENIED. Respondent needs to show continuous and successful compliance with the original Order for at least five years.
3. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
4. This order is effective the date of its signing.
