On December 11, 2013, the Wisconsin Medical Examining Board ("Board") issued a Final Decision and Order ("December 11, 2013 Order") granting Applicant a limited license to practice medicine and surgery (#61782-20) with certain terms and conditions. On October 23, 2018, the Board issued an Order Affirming Denial of Full Licensure and Imposing Additional Limitations ("October 23, 2018 Order"), further limiting Applicant's license with certain terms and conditions, including submitting an attestation that he has ceased the independent practice of medicine and surgery. On March 11, 2019, Applicant's license was suspended for failure to submit an attestation pursuant to the terms of the October 23, 2018 Order.

The Board designee has considered Applicant's request for termination of the suspension. Based upon the information of record, which includes proof that Applicant has submitted an attestation that he has ceased the independent practice of medicine and surgery, the following is entered:

ORDER

1. Applicant's request for termination of the suspension is hereby GRANTED.
2. All other terms and conditions of the December 11, 2013 Order and the October 23, 2018 Order not otherwise modified remain in full force and effect.
3. This order is effective the date of its signing.
