On March 10, 2014, the Wisconsin Board of Nursing ("Board") issued an Order For Original Limited License ("Order") granting Applicant a limited professional nursing license (#143136-30) and suspending it indefinitely. Applicant has been granted a stay of suspension and her license is currently limited with certain terms and conditions.

On August 13, 2020, the Board considered Applicant's request for access to controlled substances and a reduction in the frequency of drug and alcohol screens. Based upon the information of record, the following is entered:

ORDER

1. Applicant's request for access to controlled substances is hereby GRANTED.
2. Applicant's request for a reduction in the frequency of drug and alcohol screens is hereby DENIED for insufficient time under the Order to demonstrate adequate compliance.
3. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
4. This order is effective the date of its signing.
